STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
EIGHTY-FIVE.

AN ACT to incorporate the Pemaquid Land Company.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. F. E. Hitchcock of Rockland, in
2 the State of Maine; W. F. Sawyer of Boston, G.
3 T. Burnham of Somerville, C. W. Sawyer of Som-
4 erville, Solon Bryant of Worcester, all in the
5 Commonwealth of Massachusetts; J. E. Nichols,
6 W. P. Miller and A. H. Brackett of Bristol, in the
7 State of Maine, their associates and successors,
8 are hereby constituted a body politic and corporate,
9 by the name of the Pemaquid Land Company of
10 Bristol, with all the rights, powers and privileges

11 and subject to all the duties and liabilities pro-
12 vided by the laws of this State thereto applicable.

SECT. 2. Said corporation is authorized to pur-
2 chase, hire, or in any legal mode acquire and hold,
3 sell, lease and convey real and personal estate and
4 property in their own right and in trust as they
5 deem expedient, or for the purposes of the cor-
6 poration; to make all necessary by-laws and rules
7 for the furtherance of the purposes of this act and
8 the government of the corporation.

SECT. 3. Said corporation is authorized at any
2 time to lease any part or all of its property or
3 franchise; to purchase, erect or lease cottages and
4 all other buildings that may be needed for the
5 comfort or convenience of the proprietors or their
6 lessees; to receive in trust any money or property
7 for the purpose of erecting and leasing cottages
8 and all other buildings that may be in any
9 way necessary for the shelter, comfort or con-
10 venience of persons residing or sojourning in
11 Maine for health, recreation or business, on the
12 land that may be owned or leased by said corpora-
13 tion or put into its control as trustees as aforesaid;
14 build and maintain wharves and landings, lay out,
15 improve and ornament roads, walks and any lands
16 of said corporation; may own and operate convey-

17 ances by land or water to and from and upon any
18 lands owned or leased by said corporation; lay out
19 cables under the water from any islands owned by
20 corporation to the main land for telephone or tel-
21 egraph lines, and may make all rules necessary
22 for the protection of the same.

SECT. 4. In order to secure a sufficient and
2 regular supply of lobsters for domestic consump-
3 tion on any islands or lands under the control of said
4 corporation, it may increase the number of lobsters
5 within said limits by artificial propagation or other
6 appropriate acts and methods, under the direction
7 of the commissioners of fisheries, and shall not be
8 interfered with by other parties, but be protected
9 therein as said commissioners of fisheries shall
10 determine, and shall have the right by its agents
11 and tenants to take and catch lobsters within three
12 hundred yards of the low water line of the land
13 and islands owned or leased by said corporation
14 during each and every month, for domestic use,
15 but for no other purpose.

SECT. 5. The capital stock of said corporation shall
2 be such an amount as the stockholders, by a majority
3 vote of those present and voting, shall from time to
4 time determine, not exceeding one hundred thousand
5 dollars, said stock to be divided into the number

6 of shares and of such par value as the directors
7 shall determine.

SECT. 6. F. E. Hitchcock, J. E. Nichols, W. P.
2 Miller and A. H. Brackett, named in this act, or a
3 majority of them, may call the first meeting of said
4 corporation for the purpose of organization by
5 giving written notice thereof to each of the other
6 corporators fifteen days at least before said
7 meeting.

SECT. 7. This act shall take effect when approved.
