STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN.

AN ACT to incorporate the Penobscot Lake Dam Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. William H. Maling, Josiah W. Bod-2 well, their associates and assigns, be, and they are 3 hereby created a body politic and corporate by the 4 name of the Penobscot Lake Dam Company, with 5 all the powers rights and privileges of similar cor-6 porations.

SECT. 2. Said corporation may erect and main-2 tain a dam or dams, with side booms and sluices, 3 on the outlet of Penobscot Lake, near the foot of 4 Penobscot Lake in township number four, range

5 five, N. B. K. P. in Somerset County, to facilitate 6 the driving of logs and lumber down from said 7 lake and the brook leading down therefrom; and 8 said corporation may remove rocks, excavate 9 ledges, build dams and side dams, and make other 10 improvements for said purpose, on said brook and 11 its tributaries below said lake and dam, as far as 12 Canada Falls; and said corporation may erect and 13 maintain a dam or dams, with side booms and 14 sluices, on the outlet of Dole Brook Pond and 15 Long Pond for the aforesaid purpose, and improve 16 the navigation of Dole Brook Stream and Long 17 Pond Stream by removing rocks, excavating 18 ledges, and building dams and side dams thereon, 19 and their tributaries; and may take land and ma-20 terials for building said dams, and making said im-21 provements, and flow contiguous lands so far as 22 necessary to raise suitable heads of water. And 23 if the parties owning said land and materials can-24 not agree upon the damages therefor, then said 25 damages shall be estimated by the County Com-26 missioners for the county of Somerset, as provided 27 by law in case of taking lands for public highways; 28 and for the damage occasioned by flowing land, the 29 said corporation shall not be liable to an action at 30 common law, but the person injured may have a 31 remedy by complaint for flowing in the manner32 provided by chapter ninety-two of the Revised33 Statutes.

SECT. 3. The said corporation may demand and 2 receive a toll for the passage of logs over their 3 said dams and improvements between Penobscot 4 Lake and the Gulch below on Penobscot Brook, 5 so called, of thirty-five cents, for each thousand 6 feet, board measure, woods scale, and may demand 7 and receive a toll for the passage of logs over their 8 said dams and improvements between Dole Brook 9 Pond and the mouth of Dole Brook Stream, and 10 between Long Pond and the mouth of Long Pond 11 Stream, of fifteen cents for each thousand feet, 12 board measure, woods scale, and said corporation 13 shall have a lien upon all logs which may pass over 14 any of its dams and improvements for the payment 15 of said tolls, but the logs of each particular mark ,16 shall be holden only for the tolls of such mark, and 17 unless such toll is paid within twenty days, after 18 such logs, or a major part of them, shall arrive at 19 the Penobscot boom, or place of manufacture, said 20 corporation may seize said logs, and sell at public 21 auction so many thereof as shall be necessary to 22 pay such toll and costs and charges, notice of the 23 time and place of such sale, ten days before such

24 sale, being first given, in some newspaper printed25 at Bangor; and when said corporation shall, from26 tolls, be reimbursed for its expenditures, and eight27 per cent interest thereon, the tolls shall cease.

SECT. 4. No tolls shall be demanded or collected 2 on any logs cut on Hammond township, number 3 three range four N. B. K. P. and landed on Pen-4 obscot Brook aforesaid at points where landed and 5 driven heretofore.

SECT. 5. This act shall take effect when ap-2 proved.
