## STATE OF MAINE.

---

RESOLVE in aid of Dairying, Beef-raising and Mutton-growing Interests of the State of Maine.

---

*Resolved*, That the sum of one thousand dollars  
2 be and is hereby appropriated for the Maine State  
3 Agricultural Society, and one thousand dollars for  
4 the Eastern Maine State Fair, of which there shall  
5 be paid the sum of five hundred dollars to each of  
6 said societies during the year one thousand eight  
7 hundred and eighty-seven, and five hundred dol-  
8 lars to each of said societies during the year one  
9 thousand eight hundred and eighty-eight; *pro-*  
10 *vided*, that each of said societies appropriate an  
11 amount equal to the sum herein appropriated, and  
12 in addition thereto, for premiums to the classes men-  
13 tioned in this resolve. Four hundred dollars of

14 said appropriation shall be used annually by each  
15 society for the purpose of encouraging the dairying  
16 interests in this State; four hundred dollars for  
17 the purpose of encouraging the raising of beef and  
18 fat cattle in this State, and two hundred dollars for  
19 the purpose of encouraging mutton-growing in the  
20 State. These several sums shall be offered by the  
21 two said societies in premiums to be competed for  
22 by the citizens of this State. The list of premiums  
23 shall be arranged jointly by the executive officers  
24 of the two said societies, together with the presi-  
25 dent and secretary of the board of agriculture.

*To the Committee on Agriculture of the Legislature of  
Maine.*

The undersigned, Trustees of the Maine State Agricultural Society, recommend that \$1,000 be appropriated by the State as an annual stipend to be offered in premiums by the Maine State and the Eastern State agricultural societies, \$500 the same as last year, and \$500 as follows: \$200 for stock horses, \$100 for grange exhibits, \$100 for fat sheep, \$50 for poultry and \$50 for swine.

It is understood that the requirements pertaining to the offering and payment of the State stipend shall be the same as last year.
