STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN.

AN ACT to amend section thirty-seven of chapter eighty of the Revised Statutes, relating to Jails.

Be it enacted by the Senate and Housé of Representatives in Legislature assembled, as follows:

Section 1. Section thirty-seven of chapter eighty

- 2 of the Revised Statutes is hereby amended by add-
- 3 ing after the word "is" in the second line, the
- 4 words 'unfit for occupation or'; and by adding to the
- 5 the section the words 'And if by fire or other casualty
- 6 any jail is destroyed or rendered unfit for use, any
- 7 judge may, upon being notified by the county attor-
- 8 ney of the county where such jail was or is located,
- 9 issue his order to the sheriff and his deputies and

10 constables of said county to imprison all prisoners 11 which might be liable to imprisonment in said 12 county, to be imprisoned in the jail of some adjoin-13 ing county, said order to be printed in the newspa-14 pers of said county,' so that said section as amend-15 ed shall read as follows:

'Whenever complaint on oath is made to a judge 17 of the supreme judicial court that any jail is unfit 18 for occupation, or is insufficient for the secure keep-19 ing of any person charged with crime and commit-20 ted to await trial or under sentence, he shall cause 21 not less than three days' notice of such complaint 22 to be given to the jailer or sheriff of the county to 23 appear at the time and place fixed in such notice, 24 and if on examination the matter complained of is 25 found true, he may issue his warrant for the trans-26 fer of such prisoner at the expense of said county, 27 to any jail where he may be more securely kept. 28 And if by fire or other casualty any jail is de-29 stroyed or rendered unfit for use, any judge of the 30 Supreme Judicial Court may, upon being notified 31 by the county attorney of the county where such 32 jail was or is located, issue his order to the sheriff 33 and his deputies and constables of said county to 34 imprison all prisoners who might be liable to im-35 prisonment in said county, to be imprisoned in the

- 36 jail of some adjoining county, said order to be 37 printed in the newspapers of said county.'
 - SECT. 2. This act shall take effect upon its ap-2 proval by the Governor.
