## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN.

AN ACT to amend section forty-one of chapter forty of the Revised Statutes.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section forty-one of chapter forty

- 2 of the Revised Statutes, is hereby amended by
- 3 striking out, in the third line of said section, the
- 4 words "nor between Bangor and Brewer bridge,
- 5 over the Penobscot river," and inserting instead
- 6 thereof the following words: 'nor in the Penob-
- 7 scot river between the mouth of the Kenduskeag

8 stream,' so that said section as amended, shall read 9 as follows:

No salmon, shad, or other migratory 'SECT. 41. 10 fish, shall be taken or fished for within five hundred 11 yards of any fish-way, dam or mill-race; nor in 12 the Penobscot river, between the mouth of the 13 Kenduskeag stream and the water works dam at 14 Treat's Falls, on said river; nor between the 15 Augusta highway bridge, over the Kennebec riv-16 er, and the Augusta dam, between the first days of 17 April and November, except by the ordinary mode 18 of angling with single hook and line, or artificial 19 flies; nor shall hook and line, or artificial flies be 20 used at any time, within one hundred yards of any 21 fish-way, dam or mill-race; but this section shall 22 not apply to the taking of alewives by the town of 23 Warren, in the Georges river, and by the town of 24 Waldoboro, in the Medomak river, under the au-25 thority granted said towns by the private and 26 special laws of Massachusetts, passed March six, 27 eighteen hundred and two, and amendments there-28 to passed by the Legislature of this State. 29 penalty for violation of this section is a fine of not 30 more than fifty, nor less than ten dollars for each 31 offence, and a further fine of ten dollars for each 32 salmon, and one dollar for each shad, so taken.
