## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-ONE.

---

AN ACT to authorize the town of Skowhegan to  
perfect its title to the School Property in said town.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows :*

SECTION 1. All the school houses, lands, appa-  
2 ratus, and other property owned and used for  
3 school purposes by the several school districts in  
4 the town of Skowhegan on the seventh day of  
5 March, in the year of our Lord one thousand eight  
6 hundred and eighty-seven, and which said dis-

7 tricts might lawfully sell and convey, shall, before  
8 the first day of April, in the year of our Lord one  
9 thousand eight hundred and ninety-two, be  
10 appraised under the direction of said town, at  
11 the value said property bore on said seventh day  
12 of March eighteen hundred and eighty-seven; and  
13 at the next annual assessment a tax shall be levied  
14 upon the whole town, equal to the whole amount  
15 of said appraisal, or such part thereof as the town  
16 shall vote, and the remainder of said appraisal, if  
17 any, shall be levied by tax upon the whole town at  
18 the second and third annual assessments there-  
19 after, or at the second alone, as the town shall  
20 vote; and there shall be remitted to the taxpayers  
21 of each district the said appraised value of its  
22 property thus taken, in the same proportion,  
23 annually, as the tax therefor shall be levied; or the  
24 difference in value of the property of the several  
25 districts may be adjusted in any other manner  
26 agreed upon by the parties in interest; and in  
27 either case the proceedings shall have in all  
28 respects the same force and effect as though the  
29 same had originally been had and done in accord-  
30 ance with the provisions of section three of chap-  
31 ter eleven of the Revised Statutes, and amend-

32 ments thereto. In case of union districts, formed  
33 by said town in concurrence with other towns, the  
34 provisions of chapter three hundred and eighty of  
35 the public laws of eighteen hundred and eighty-  
36 five shall be followed.
