STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED
AND NINETY-FIVE.

AN ACT to amend section two of chapter six hundred and thirty-two, of the Private and Special Laws of 1893, relating to the protection of trout, land-locked salmon, white perch, pickerel, minnows, shiners, fresh water hering and food fish in the ponds, lakes, tributaries, outlets and inlets of the same lying wholly or in part in the towns of Winthrop, Monmouth and Litchfield.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Section two of chapter six hundred and thirty-two of 2 the Private and Special Laws of 1893 is hereby amended 3 so that said section as amended shall read as follows :

‘Section 2. No person shall sell, or expose for sale, or 5 have in possession with intent to sell or transport from

6 place to place, any white perch, smelts, minnows, shiners,
7 fresh water herring, or any fish commonly used for bait,
8 taken from any of the following named waters: All the
9 brooks and streams and tributaries thereto, that flow into
10 any of the ponds or lakes lying wholly or in part in the
11 towns of Winthrop, Monmouth and Litchfield, and all
12 streams and brooks that flow directly or indirectly into
13 Cobbosseecontee stream, so-called, in the county of Ken-
14 nebec, and all the lakes and ponds lying wholly or in part
15 in the towns of Winthrop, Monmouth and Litchfield. But
16 this act shall not prohibit the taking of white perch for
17 consumption in the family of the person taking them, or
18 the taking of smelts, shiners, minnows, and other fish
19 commonly used for bait for one's own lawful fishing, in
20 quantities not to exceed five hundred in any one month.
21 Provided, further, that it shall be unlawful for any person
22 to fish for, take, catch or kill, any white perch, trout, or
23 land-locked salmon, or other fish, through, or on the ice,
24 from Lake Maranacook, so-called, in Winthrop and Read-
25 field, in said county of Kennebec.'
