STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND FIVE.

AN ACT to authorize the Dover Gas Light Company to acquire
the property and franchises of the United Gas and Electric
Company.

*Be it enacted by the Senate and House of Representatives in
Legislature assembled, as follows:*

Section 1. The Dover Gas Light Company, a corporation
2 existing under the laws of New Hampshire, is hereby author-
3 ized to acquire by purchase or otherwise, the franchises and
4 property of the United Gas and Electric Company, situate
5 in the State of Maine and, upon the acquisition of the same,
6 is invested and empowered to exercise and enjoy all the
7 powers, privileges and franchises of said United Gas and
8 Electric Company in the towns of Lebanon, Berwick, North
9 Berwick, South Berwick, Wells and Eliot in the county of

10 York, said State, subject, however, to all its duties and
11 liabilities.

Sect. 2. Said Dover Gas Light Company, in order to pro-
2 cure funds for the purchase of said property and franchises
3 and for other corporate purposes, is hereby authorized to
4 issue its bonds in an amount not exceeding five hundred
5 thousand dollars and to secure the same by a mortgage upon
6 its property and franchises now owned or hereafter acquired
7 by it.

Sect. 3. The stockholders of said Dover Gas Light Com-
2 pany, their successors and assigns, upon the acquisition of
3 the property and franchises of said United Gas and Electric
4 Company in Maine are constituted a body corporate and
5 politic, under the name of the Dover Gas Light Company,
6 for the purpose of exercising and enjoying all the powers,
7 privileges and franchises of said United Gas and Electric
8 Company in said towns of Lebanon, Berwick, North Ber-
9 wick, South Berwick, Wells and Eliot.

Sect. 4. Said Dover Gas Light Company shall have all the
2 powers and privileges and be subject to all the duties and
3 liabilities by law incident to corporations of a similar nature,
4 and the stock and bonds of the said New Hampshire corpo-
5 ration shall be and constitute the stock and bonds of the
6 corporation created by this act and the owners and holders
7 thereof shall be and constitute the owners and holders of the
8 same in this corporation.

Sect. 5. This act shall take effect when approved.
