IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND SEVEN.

AN ACT to incorporate the town of East Millinocket.

---

*Be it enacted by the Senate and House of Representatives in  
Legislature assembled, as follows:*

Section 1. So much of Township A, Range 7, W. E. L. S.,  
2 in the county of Penobscot as is bounded as follows, namely:  
3 Beginning at the northeast corner of said township; thence  
4 southerly on the east line of said township to the middle  
5 of the West Branch of the Penobscot river; thence westerly  
6 up the middle of the line of the West Branch of the Penob-  
7 scot river to the Cassidy and Webber line, so called; thence  
8 northerly on the Cassidy and Webber line to the north line

9 of said township; thence easterly on the north line of said  
10 township to the point begun at, is hereby incorporated as  
11 a town under the name of East Millinocket, and the inhab-  
12 itants thereof are hereby invested with all the powers and  
13 privileges and subject to all the duties and liabilities incident  
14 to other towns in this State. Only the public lot in that  
15 part of said township hereby incorporated shall belong to  
16 said town of East Millinocket.

Sect. 2. Any justice of the peace may call the first meet-  
2 ing of the town of East Millinocket by posting a warrant  
3 therefor, stating the objects of said meeting, in three public  
4 and conspicuous places in said town at least seven days  
5 before the time of holding said meeting.

Sect. 3. Said town of East Millinocket is hereby author-  
2 ized to contract for a supply of water for sanitary, municipal  
3 and other public purposes, including the extinguishment of  
4 fires upon such terms and conditions as the said town may  
5 deem fit and proper, and to enter into contract with any  
6 lighting company for lighting the streets and other places  
7 in said town under municipal control.

Sect. 4. This act shall take effect when approved .
