## STATE OF MAINE.

Ordered, the Senate concurring, that the Committee on 2 Appropriations and Financial Affairs is hereby directed 3 to cause to be printed and furnished each week to the sev-4 eral members of the Senate and House a revised list or 5 schedule, in pamphlet or other convenient form, of all mes-6 sages, documents, reports, petitions, bills, resolves, orders 7 or other papers in the possession of the Legislature from 8 the commencement of the session recommending or calling 9 for the appropriation or expenditure of money by the State, 10 omitting therefrom all matters on which final action has 11 been taken by the two branches wholly denying the proposed 12 expenditure. Said schedule shall classify the expenditures 13 as "State," "County," "Municipal," "Private," or "Mis-14 cellaneous," according to the fact, and under each head-15 ing shall group the expenditures for the same general ob-

16 ject under appropriate sub-titles. Said schedule shall show 17 the date to which it is revised, and shall exhibit in tabular 18 form the following facts:

Name of recipient of the appropriation or expenditure; 20 object, concisely stated; nature of document calling for 21 same; number of Senate or House document, if any; com-22 mittee to whom referred; amount called for in 1909; amount 23 called for in 1910; total amount called for; amount actually 24 appropriated by action of the Legislature for 1909; amount 25 so appropriated for 1910; and total amount actually appro-26 priated. When actual appropriation has been made, the 27 item shall be eliminated from the other money columns. 28 Each of the five classes of expenditures shall be footed, 29 and a summary showing the grand total shall be added, fol-30 lowed by a statement of all matters wherein the amount or 31 estimate is unspecified, grouped under the heading "Amount 32 not Specified."

When several petitions or papers call for the same identi-34 cal appropriation or expenditure, but one of them need be 35 mentioned.

And, further

Ordered, That the Chairman of said Appropriation Com-38 mittee is authorized and directed forthwith to employ a com-39 petent clerk for the sole purpose of preparing and revising 40 said schedule, under the supervision of said chairman.

And, further

Ordered, That the Secretary of the Senate, Clerk of the 43 House, and Chairman, Clerks and Secretaries of the sever-44 al committees shall afford every reasonable facility to said 45 special clerk for the daily examination of papers and dis-46 charge of his duties.
