STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINE.

AN ACT to amend section twenty-two of chapter six of the Revised Statutes, relating to the regulation and conduct of Elections.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Chapter six of the Revised Statutes is hereby
- 2 amended by striking out section twenty-two as amended
- 3 by chapter one hundred forty-eight of the Public Laws of
- 4 the year one thousand nine hundred and five, and insert-
- 5 ing in place thereof the following:
- 'Sect. 22. The municipal officers in each city, town or
- 7 plantation as aforesaid shall cause each polling place ir
- 8 their respective cities, towns and plantations to be provided
- 9 with a sufficient number of suitable marking shelves or

10 compartments where voters may conveniently and secretly II mark their ballots; and they shall cause a guard rail to be 12 so placed that only persons who are inside thereof can ap-13 proach within six feet of the ballot boxes or of the mark-14 ing shelves or compartments. The ballot boxes and the 15 making shelves or compartments shall be in open view of 16 persons in the polling place outside the guard rail. The 17 number of marking shelves or compartments shall be not 18 less than one for every one hundred voters at such polling 19 place, and not less than three in any town or plantation 20 and not less than five in any ward of a city. Each marking 21 shelf or compartment shall at all times be provided witl. 22 proper supplies and conveniences for marking the ballots. 23 No persons other than the election officers, election clerks 24 and voters admitted as hereinafter provided, shall be per-25 mitted within said rail, except by authority of the presiding 26 officer or officers for the purpose of keeping order and 27 enforcing the law.'
