STATE OF MAINE

HOUSE AMENDMENT "A" TO HOUSE DOCUMENT NO. 745.

Amend Aroostook County Apportionment by striking out 2 the word "and" in line seven, and inserting in line seven 3 after the word "Reed," the words 'and four, range three; 4 and by inserting in line twenty-one after the words "range 5 three," the words 'one representative;' and by inserting in 6 line twenty-nine after the words "range four" the words 7 'nine, range five,' so that said apportionment as amended 8 shall read as follows:

'The county of Aroostook shall choose fifteen representa-10 tives to be apportioned as follows: IIersey, Island Falls, 11 Crystal, Sherman, Benedicta, Silver Ridge, Molunkus, Mac-

12 wahoc, three, range four, two, range four, one, range four, 13 and one, range five, one representative; Linneus, Hodgdon, 14 Cary, A, range two, Leavitt, Amity, three, range three, 15 Glenwood, Haynesville, Orient, Weston, Bancroft, Reed, 16 and four, range three, one representative; Houlton, one rep-17 resentative; Dyer Brook, Oakfield, Moro, Merrill, Smyrna, 18 Limerick, Ludlow, Hammond, Littleton, seven, range three, 19 seven, range four, seven, range five, eight, range three, eight, 20 range four, and eight, range five, one representative; Mon-21 ticello, Bridgewater, Blaine, Mars Hill, C plantation, D 22 plantation and E plantation, one representative; Easton, 23 Westfield, Chapman, Mapleton, Washburn, nine, range 24 three, and ten, range three, one representative; Presque Isle, 25 one representative; Fort Fairfield, one representative; Cari-26 bou, one representative; Limestone, Caswell, Connor, New 27 Sweden, Westmanland, Stockholm, Woodland and sixteen, 28 range four, one representative; Van Buren, Hamlin, Cyr, 29 Grand Isle, seventeen, range three, one representative; 30 Frenchville, St. Agatha and Madawaska, one representative; 31 Fort Kent and Wallagrass, one representative; Eagle Lake, 32 Hill, Allagash, St. Francis, St. John, New Canada, seven-33 teen, range four, seventeen, range five, sixteen, range five, 34 fifteen, range six, fourteen, range six, and all other unorgan-35 ized townships, one representative; Ashland, Garfield, Nash-36 ville. Portage Lake, Perham, Wade, Castle Hill, Masardis, 37 Oxbow, nine, range four, ten, range four, ten, range six, 38 eleven, range four, nine, range five, twelve, range five, thir-39 teen, range five, and fourteen, range five, one representative.'

HOUSE AMENDMENT "B" TO HOUSE DOCUMENT NO. 745.

Amend the Washington County apportionment by striking 2 out the word "Marshfield" in the fourth line, and inserting 3 the word 'Marshfield' at the beginning of the eighth line, 4 and before the word "and," so that said apportionment for 5 Washington county shall read as follows:

'The county of Washington shall choose nine representa-7 tives to be apportioned as follows: East Machias, Marion, 8 plantation number fourteen, Dennysville, Edmunds, Craw-9 ford, Whiting, and Machiasport, one representative; Cooper, 10 Perry, Alexander, Meddybemps, Charlotte, Robbinston, and 11 Pembroke, one representative; Centerville, Whitneyville, 12 Roque Bluffs, Northfield, Wesley, Machias, Marshfield and 13 Jonesboro, one representative; Trescott, Lubec and Cutler, 14 one representative; Eastport, one representative; Calais, one 15 representative; Baileyville, Baring, plantation number thirty-16 one, Danforth, Brookton, Forest City, Talmadge, Topsfield, 17 Vanceboro, Waite, Codyville, Grand Lake Stream, Prince-18 ton and all territory not otherwise classified, one representa-19 tive; Milbridge, Steuben, Cherryfield, Beddington and De-20 blois, one representative; Addison, Columbia Falls, Harring-21 ton and Jonesport, one representative.'
