RESOLVE, in favor of aid in constructing a road in the plantation of New Canada.

Resolved, That there be and hereby is appropriated the 2 sum of five hundred dollars (\$500) to aid the plantation of 3 New Canada in constructing a road which shall lead from 4 the Caribou road to the main road of New Canada; pro-5 vided that there be appropriated by said plantation of New 6 Canada the sum of five hundred dollars (\$500) for the 7 same purposes; both sums to be expended under the super-8 vision of the State Highway Commission; and further pro-9 vided that this resolve sall be void and of no effect unless 10 said plantation in accepting this appropriation thereby and 11 in consideration thereof shall undertake that all road ma-12 terial, including clay, gravel, sand and rock, necessary for 13 the improvement contemplated by this resolve shall be fur-

14 nished without expense to the state, and that said plantation 15 shall assume and pay all damages whatsoever arising from 16 the taking of land or from the change of grade, drainage or 17 alignment deemed by the State Highway Commission as 18 necessary for said improvement. Said way when so im-10 proved shall be thereafter continually maintained under the 20 direction and control of said commission at the joint expense 21 of the state and said plantation; the charge against said 22 plantation for maintenance of said way shall not exceed 23 fifty percentum of the actual cost of such maintenance nor 21 an average of thirty dollars per mile per annum, and the 25 payment by said town of its said share of said maintenance 26 shall be enforced in the same manner as provided in sections 27 ten and twenty-five of chapter one hundred thirty of the 28 public laws of nineteen hundred and thirteen. The share 20 of the state in said maintenance shall be paid out of the fund 30 for administration and maintenance created by virtue of sec-31 tion thirty-three of said chapter one hundred and thirty.

STATEMENT OF FACTS.

Altogether there are four miles of this road for which assistance is asked. Two and one-half miles of the road are partly built and there are 1½ miles which must be entirely built new. On the 21/2-mile section the right of way has been cleared and the stumps have been taken out and a little rough grading has been done, but no culverts have been built. The 11/2 mile cannot be used except in the winter, after a considerable amount of snow is on the ground. The proposition of the plantation is to make a good graded road over this whole 4 miles that can be used at any time of the year, thus connecting two sections of the town and considerably shortening the distance from the Saucier settlement, so called, to Soldier Pond. In 1910 the population was 500 and the valuation of the town was \$61,243 and without assistance the town is unable to build this section of road and consequently open up new territory for further settlement. This improvement would also give the inhabitants of New Canada plantation a better opportunity to market their supplies, Soldier Pond being their railroad station.
