#### STATEMENT OF FACTS.

After being mustered out of the service and returning to his home in Linneus, Private Allan Shenneck of Company L, Second Maine Infantry, N. G. S. M., the minor son of parents who have not the means to pay the expenses of his last sickness and burial, died on November 19th, 1916, at the Aroostook Hospital in Houlton of yellow fever.

Vouchers and bills for the expenses herein noted are appended herewith.

It is hereby certified that the soldier named above was actually an enlisted man in the National Guard of Maine and answered the President's call of June 18, 1916.

To Whom It May Concern:

This is to certify that I saw Allen Shenneck in consultation with Dr. A. G. Walker on two occasions at the Aroostook Hospital, Houlton, Me. Despite the very long incubation period his symptoms were such that I feel the attending physician was justified in diagnosing the case as one of Yellow Fever. Mr. Shenneck died Nov. 19, 1916.
