STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVENTEEN

RESOLVE in favor of the Reformatory for Women for maintenance and other purposes for the years nineteen hundred seventeen and nineteen hundred eighteen.

Resolved, That there be, and hereby is appropriated.

For the Reformatory for Women.

*For personal services, namely, for salaries and wages of
2 all officers and employees except those wholly engaged in
3 repairs of buildings and equipment, for the year nineteen
4 hundred seventeen, the sum of four thousand seven hun-*

5 dred and sixty (\$4,760.00) dollars, and for the year nine-
6 teen hundred eighteen, the sum of six thousand seven hun-
7 dred and eighty (\$6,780.00) dollars.

For food supplies, namely, all articles of food, for the year
2 nineteen hundred seventeen, the sum of one thousand two
3 hundred and ninety (\$1,290.00) dollars, and for the year
4 nineteen hundred eighteen, the sum of two thousand thirty
5 (\$2,030.00) dollars.

For clothing, namely, all articles of personal clothing and
2 materials for making the same, for the year nineteen hun-
3 dred seventeen, the sum of four hundred and thirty
4 (\$430.00) dollars, and for the year nineteen hundred eight-
5 een, the sum of nine hundred and seventy-five (\$975.00)
6 dollars.

For repairs and equipment, namely, all materials and sup-
2 plies required for upkeep of grounds, buildings and attached
3 fixtures; all additions to and repairs and replacements of
4 furniture and equipment, including farm equipment and live-
5 stock, and all personal services rendered wholly in connec-
6 tion with repair work, for the year nineteen hundred seven-
7 teen, the sum of nine hundred and fifty (\$950.00) dollars,
8 and for the year nineteen hundred eighteen, the sum of
9 nine hundred and fifty (\$950.00) dollars.

For general expenses, namely, all other materials, supplies
2 and expenses incident to maintenance of the institution and
3 the inmates thereof, whether present or absent, for the year
4 nineteen hundred seventeen, the sum of six thousand five

5 (\$6,005.00) dollars, and for the year nineteen hundred eight-
6 een, the sum of four thousand three hundred and ninety
7 (\$4,390.00) dollars.

Provided, that any balance of the sums above appropriated
2 for the year nineteen hundred seventeen which may remain
3 unexpended at the end of the year shall be available for
4 expenditure during the year nineteen hundred eighteen, and
5 provided further that the governor and council may, by
6 order, upon recommendation of the trustees of the said in-
7 stitution, authorize the use of unexpended balances of any
8 of the above appropriations to meet deficiencies in other
9 appropriations for such institution.

STATEMENT OF FACTS.

The above items are the amounts necessary for the maintenance of this state institution for the years nineteen hundred seventeen and nineteen hundred eighteen.
