### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to amend chapter two hundred sixty-eight of the Public Laws of nineteen hundred seventeen relating to Dental Hygienists.

Be it enacted by the People of the State of Maine, as follows:

Section 2 of chapter 268 of the laws of 1917 is hereby 2 amended by inserting after the word "examination" in the

- 3 tenth line thereof the following: 'which certificate shall be
- 4 displayed in a conspicuous place in the room or rooms in
- 5 which she practices' and by adding at the end of said section
- 6 the following, 'said certificate shall be considered a license
- 7 to practice as a dental hygienist in this state, except that it
- 8 shall be unlawful for any person to practice as a dental

9 hygienist in this state in any year after the year in which 10 said certificate is issued to her unless she shall pay to the 11 treasurer of the state board of dental examiners on or be12 fore January 1st of said year a fee of one dollar for which 13 she shall receive a registration card, which card shall be 14 placed beside or attached to the certificate above mentioned,' 15 so that said section, as amended, shall read as follows:

'Sect. 2. Examination; qualifications. No person shall 2 enter practice as a dental hygienist in this state until sle has 3 passed an examination given her by the board of dental 4 examiners of this state, or a sub-committee of said board 5 which it may appoint, under such rules and regulations as 6 it may deem fit and proper to formulate. The fee for said 7 examination shall be ten dollars and any applicant failing 8 to pass said examination shall be entitled to one additional 9 examination without further cost. The fee for each re-10 examination after the first shall be five dollars. The said 11 board of dental examiners shall issue certificates of ability to 12 practice as dental hygienists in this state to those who have 13 passed said examination, which certificate shall be displayed 14 in a conspicuous place in the room or rooms in which she 15 practices, provided, however, that no person shall be entitled 16 to such certificate unless she shall be eighteen years of age, 17 of good moral character and shall have had an education 18 equivalent to that attained by one year's attendance upon the 19 class A high schools of this state as defined by section sev-20 enty-three of chapter sixteen of the Revised Statutes and

21 unless she is a graduate of a reputable training school for 22 dental hygienists or shall present a sworn statement by a 23 dentist licensed to practice dentistry in this state that she 24 has completed a course of at least six months' training as a 25 dental hygienist under him. Said certificate shall be con-26 sidered a license to practice as a dental hygienist in this 27 state, except that it shall be unlawful for any person to 28 practice as a dental hygienist in this state in any year after 29 the year in which said certificate is issued to her unless she 30 shall pay to the treasurer of the state board on or before 31 January 1st of said year a fee of one dollar for which she 32 shall receive a registration card, which card shall be placed 33 beside, or attached to the certificate above mentioned.'
