STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to Amend Section Forty-eight of Chapter Fourteen of the Revised Statutes, Relating to the Passamaquoddy Tribe of Indians.

Be it enacted by the People of the State of Maine, as follows:

Section forty-eight of chapter fourteen of the revised stat-2 utes is hereby amended by adding thereto the following:

'And when any member of said tribe is found destitute and

- 2 in distress beyond the tribal reservation and is relieved by
- 3 the town in this state where he is so found, the overseers
- 4 of the poor of said town may send to the agent a statement
- 5 specifying the nature, dates and amounts of the supplies
- 6 furnished, which shall be transmitted to the governor and

7 council with such additional statements of fact as said agent 8 may think proper; and the state shall reimburse said town 9 for the relief so furnished, to such extent as the governor 10 and council adjudged to have been necessarily expended 11 therefor,' so that said section as amended shall read as 12 follows:

'Sect. 48. Agent may remove distressed poor to reserva-2 tion. P. & S. L. 1907, c. 208. Any member of the Passa-3 maquoddy tribe, requiring assistance under the provisions 4 of the preceding section, relating to aid to the distressed 5 poor of said tribe, may be removed by the agent of said 6 tribe from any place in which he may be residing, or be 7 found, to either of the Indian reservations provided for 8 said tribe, or may be removed from one of such reservao tions to another such reservation, whenever, in the judg-10 ment of the agent, such removal should be made. And II when any member of said tribe is found destitute and in 12 distress beyond the tribal reservation and is relieved by 13 the town in this state where he is so found, the overseers 14 of the poor of said town may send to the agent a statement 15 specifying the nature, dates and amounts of the supplies 16 furnished, which shall be transmitted to the governor and 17 council with such additional statements of fact as said agent 18 may think proper; and the state shall reimburse said town 19 for the relief so furnished, to such extent as the governor 20 and council adjudge to have been necessarily expended 21 therefor.'
