STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND NINETEEN

RESOLVE, Providing for the Care, Support and Medical or Surgical Treatment of Dependent Persons in or by Certain Charitable and Benevolent Institutions and Organizations Not Owned or Controlled by the State, and for Other Purposes.

Resolved: That there be appropriated for the year nine-
2 teen hundred and nineteen, the sum of one hundred forty-
3 five thousand, one hundred fifty dollars, and for the year
4 nineteen hundred and twenty, the sum of one hundred forty-
5 six thousand, one hundred fifty dollars, for the necessary
6 care and medical or surgical treatment, at the rates speci-
7 fied and in or by the institutions and organizations named,

8 of certain classes of persons whose own resources, or the
9 resources of whose responsible relatives as defined by sec-
10 tion eighteen of chapter twenty-nine of the revised stat-
11 utes, are insufficient to pay for the same, and for other
12 purposes, namely:

For the care and support of children under sixteen years
2 of age, including those supported away from their parents
3 under the provisions of sections fifty-one to fifty-five in-
4 clusive, chapter sixty-four, revised statutes, and acts amend-
5 atory thereof, at not to exceed three dollars and fifty cents
6 per week, including direct payments from sources other
7 than the state:

Children's Aid Society, Belfast, one thousand seven hun-
2 dred dollars for the year nineteen hundred and nineteen
3 and one thousand seven hundred dollars for the year nine-
4 teen hundred and twenty.

Eastern Maine Orphans' Home, Bangor, one thousand
2 two hundred dollars for the year nineteen hundred and
3 nineteen, and one thousand two hundred dollars for the
4 year nineteen hundred and twenty.

Girls' Orphanage, Lewiston, two thousand five hundred
2 dollars for the year nineteen hundred and nineteen, and
3 two thousand five hundred dollars for the year nineteen
4 hundred and twenty.

Healy Asylum, Lewiston, five thousand dollars for the
2 year nineteen hundred and nineteen, and five thousand dol-
3 lars for the year nineteen hundred and twenty.

Lewiston and Auburn Children's Home, seven hundred
2 fifty dollars for the year nineteen hundred and nineteen,
3 and seven hundred fifty dollars for the year nineteen hun-
4 dred and twenty.

Saint Elizabeth's Roman Catholic Orphan Asylum, and
2 Holy Innocents' Home, Portland, four thousand five hun-
3 dred dollars for the year nineteen hundred and nineteen,
4 and four thousand five hundred dollars for the year nine-
5 teen hundred and twenty.

W. C. T. U. Temporary Home, Gardiner, seven hundred
2 fifty dollars for the year nineteen hundred and nineteen,
3 and seven hundred fifty dollars for the year nineteen hun-
4 dred and twenty.

For the care and support of children as above specified,
2 at actual cost but not exceeding three dollars and fifty cents
3 per week, including direct payments from sources other
4 than the state:

Children's Heart Work Society, Portland, one thousand
2 dollars for the year nineteen hundred and nineteen, and one
3 thousand dollars for the year nineteen hundred and twenty.

Children's Protective Society, Portland, one thousand two
2 hundred dollars for the year nineteen hundred and nine-
3 teen, and one thousand two hundred dollars for the year
4 nineteen hundred and twenty.

Maine Children's Home Society, Augusta, three thousand
2 dollars for the year nineteen hundred and nineteen, and

3 three thousand dollars for the year nineteen hundred and
4 twenty.

York County Children's Aid Society, Saco, one thousand
2 five hundred dollars for the year nineteen hundred and
3 nineteen, and one thousand five hundred dollars for the
4 year nineteen hundred and twenty.

For medical and surgical treatment and care of children
2 and adults,—including children under sixteen years of age,
3 who are being supported away from their parents under
4 the provisions of sections fifty-one to fifty-five, inclusive,
5 chapter sixty-four, revised statutes, and acts amendatory
6 thereof, but not including persons sixteen years of age and
7 over, who, directly or indirectly, within a period of three
8 months prior to receiving such treatment or care, have
9 been supported or assisted under the provisions of chapter
10 twenty-nine, revised statutes, and acts amendatory there-
11 of—at not to exceed fourteen dollars per week, including
12 direct payments from sources other than the state:

Augusta General Hospital, Augusta, six thousand five
2 hundred dollars for the year nineteen hundred and nine-
3 teen, and seven thousand five hundred dollars for the year
4 nineteen hundred and twenty.

Bar Harbor Medical and Surgical Hospital, two thousand
2 dollars for the year nineteen hundred and nineteen, and
3 two thousand dollars for the year nineteen hundred and
4 twenty.

Bath City Hospital, Bath, two thousand dollars for the

2 year nineteen hundred and nineteen, and two thousand dol-
3 lars for the year nineteen hundred and twenty.

Calais Hospital, one thousand dollars for the year nine-
2 teen hundred and nineteen, and one thousand dollars for
3 the year nineteen hundred and twenty.

Castine General Hospital, five hundred dollars for the
2 year nineteen hundred and nineteen, and five hundred dol-
3 lars for the year nineteen hundred and twenty.

Central Maine General Hospital, Lewiston, six thousand
2 dollars for the year nineteen hundred and nineteen, and
3 six thousand dollars for the year nineteen hundred and
4 twenty.

Charles A. Dean Hospital, Greenville Junction, one thou-
2 sand two hundred dollars for the year nineteen hundred
3 and nineteen, and one thousand two hundred dollars for
4 the year nineteen hundred and twenty.

Children's Hospital, Portland, thirty-six thousand dollars
2 for the year nineteen hundred and nineteen, and thirty-six
3 thousand dollars for the year nineteen hundred and twenty.

Eastern Maine General Hospital, Bangor, ten thousand
2 dollars for the year nineteen hundred and nineteen, and ten
3 thousand dollars for the year nineteen hundred and twenty.

Gardiner General Hospital, Gardiner, five hundred dol-
2 lars for the year nineteen hundred and nineteen, and five
3 hundred dollars for the year nineteen hundred and twenty.

Knox County General Hospital, Rockland, one thousand
2 five hundred dollars for the year nineteen hundred and

3 nineteen, and one thousand five hundred dollars for the
4 year nineteen hundred and twenty.

Madigan Memorial Hospital, Houlton, one thousand five
2 hundred dollars for the year nineteen hundred and nine-
3 teen, and one thousand five hundred dollars for the year
4 nineteen hundred and twenty.

Maine Eye and Ear Infirmary, Portland, five thousand
2 dollars for the year nineteen hundred and nineteen, and
3 five thousand dollars for the year nineteen hundred and
4 twenty.

Maine General Hospital, Portland, eight thousand five
2 hundred dollars for the year nineteen hundred and nine-
3 teen, and eight thousand five hundred dollars for the year
4 nineteen hundred and twenty.

Northern Maine General Hospital, Eagle Lake, two thou-
2 sand five hundred dollars for the year nineteen hundred
3 and nineteen, and two thousand five hundred dollars for
4 the year nineteen hundred and twenty.

Old Town Hospital, Old Town, one thousand dollars for
2 the year nineteen hundred and nineteen, and one thousand
3 dollars for the year nineteen hundred and twenty.

Presque Isle General Hospital, seven hundred fifty dollars
2 for the year nineteen hundred and nineteen, and seven hun-
3 dred fifty dollars for the year nineteen hundred and twenty.

Rumford Hospital Association, Rumford, one thousand
2 dollars for the year nineteen hundred and nineteen, and one
3 thousand dollars for the year nineteen hundred and twenty.

Sisters of Charity, Waterville, five hundred dollars for
2 the year nineteen hundred and nineteen, and five hundred
3 dollars for the year nineteen hundred and twenty.

St. Mary's General Hospital, Lewiston, six thousand dol-
2 lars for the year nineteen hundred and nineteen, and six
3 thousand dollars for the year nineteen hundred and twenty.

Trull Hospital Aid Association, Biddeford, five hundred
2 dollars for the year nineteen hundred and nineteen, and five
3 hundred dollars for the year nineteen hundred and twenty.

Waldo County General Hospital, Belfast, seven hundred
2 fifty dollars for the year nineteen hundred and nineteen,
3 and seven hundred fifty dollars for the year nineteen hun-
4 dred and twenty.

Webber Hospital Association, Biddeford, four thousand
2 dollars for the year nineteen hundred and nineteen, and
3 four thousand dollars for the year nineteen hundred and
4 twenty.

York Hospital, York Village, one thousand two hundred
2 dollars for the year nineteen hundred and nineteen, and
3 one thousand two hundred dollars for the year nineteen
4 hundred and twenty.

For the care and medical and surgical treatment of mater-
2 nity patients and their children, at not to exceed seven
3 dollars per week for the mother and not to exceed three
4 dollars and fifty cents per week for the child, including
5 direct payments from sources other than the state:

Good Samaritan Home, Bangor, two thousand seven hun-

2 dred fifty dollars for the year nineteen hundred and nine-
3 teen, and two thousand seven hundred fifty dollars for the
4 year nineteen hundred and twenty.

Temporary Home for Women and Children, Portland, two
2 thousand five hundred dollars for the year nineteen hun-
3 dred and nineteen, and two thousand five hundred dollars
4 for the year nineteen hundred and twenty.

For the care and support of homeless women :

Old Ladies' Home, Belfast, two hundred dollars for the
2 year nineteen hundred and nineteen, and two hundred dol-
3 lars for the year **nineteen hundred and twenty.**

For the care and support of deaf persons sixteen years
2 of age or over :

Maine Mission for the Deaf, Bangor, two hundred dollars
2 for the year nineteen hundred and nineteen, and two hun-
3 dred dollars for the year nineteen hundred and twenty.

For the education of the adult blind, in order that they
2 may become self-supporting at not exceeding seven dollars
3 per week, including direct payments from sources other
4 than the state :

Maine Institution for the Blind, Portland, sixteen thou-
2 sand dollars for the year nineteen hundred and nineteen,
3 and sixteen thousand dollars for the year nineteen hundred
4 and twenty.

Provided, that the amount paid by the state to any of
2 the aforesaid institutions or organizations during the year
3 for which the appropriation is made, shall not exceed the

4 difference between the ordinary maintenance expenses of
5 the institution or organization, and the receipts in direct
6 payment for board, care or treatment from other sources
7 than the state for the last fiscal year for which said insti-
8 tution or organization has filed a report with the state
9 board of charities and corrections.

And provided, that in case of the Maine Institution for
2 the Blind, the organization of the board of directors shall
3 continue to conform to the provisions of chapter fifty-two
4 of the resolves of nineteen hundred and seventeen.
