Ordered, the Senate concurring, that a joint special committee, consisting of the speaker of the house, ex-officio,
and three members upon the part of the house, to be named
by the speaker, and the president of the senate, ex-officio,
and two members upon the part of the senate, to be named
by the president of the senate, be appointed to investigate
the fuel situation in the state of Maine. And be it further
ordered that such committee shall proceed forthwith to the
consideration of the fuel situation in all its aspects as affecting ing the health, comfort, conveniences and safety of the peo-

12 power to summon witnesses, take testimony, compel the 13 production of books, records and all data germane to said 14 investigation, administer oaths to witnesses, punish for con-15 tempt and employ all necessary assistance including counsel.

Bt it further ordered, that it is the sense of the legislature 2 that the present condition creates such an exigency that this 3 committee shall be directed to proceed with the utmost dis-4 patch and to report from time to time to the present legis-5 lature for further authority, instructions or action.
