STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Regulate the Sale of Apples in Open Packages.

Be it enacted by the People of the State of Maine, as follows: Section I. Section twenty-seven of chapter thirty-six of 2 the revised statutes of nineteen hundred and sixteen, as 3 amended by chapter ninety-four of the public laws of nine-4 teen hundred and twenty-three, is hereby amended by in-5 serting in the first line of said section after the word 6 "closed" the words 'or open,' so that said section as amended

7 shall read as follows:

'Sect. 2. The standard grade for apples when packed in 2 closed or open packages shall be as follows:

First: Fancy, shall consist of apples of one variety, above

2 the average size and color for the variety, and none smaller 3 than two and one-half inches in diameter, sound and free 4 from worm holes, bruises, scab or any other defect that 5 materially injures the appearance or useful quality of the 6 apples, and shall be properly packed in clean, strong pack-7 ages.

Second: Number one, or class one, shall consist of well 2 matured apples of one variety of normal shape and good 3 color for the variety, not less than two and one-quarter 4 inches in diameter, sound and free from all defects such 5 as worm holes, bruises, scab or any other defect that materi-6 ally injuries the appearance or useful quality of the apple, 7 and shall be properly packed in clean, strong packages.

Third: Number two, or class two, shall consist of well 2 matured apples of one variety not less than two inches in 3 diameter, of medium color for the variety and normal shape. 4 Apples two and one-quarter inches in diameter or less must 5 be sound. Apples more than two and one-quarter inches 6 in diameter may have one defect such as a worm hole or a 7 bruise, if the skin is not broken and shall be properly packed 8 in clean, strong packages.

Fourth: Unclassified. Apples not conforming to the fore-2 going conditions as to variety, size and other conditions, 3 shall be classed as Unclassified.

Fifth: The minimum size of the fruit in all classes or 2 grades, including the Fancy and Unclassified, shall be de-

3 termined by taking the transverse diameter of the smallest 4 fruit in the package at right angles to the stem and blossom 5 end. Minimum sizes shall be stated in variations of one-6 quarter of an inch like two inches, two and one-quarter 7 inches, two and one-half inches, two and three-quarter 8 inches, three inches, three and one-quarter inches, and so 9 on, in accordance with the facts.

Minimum sizes may be designated by figures instead of 2 words. The word "minimum" may be designated by using 3 the abbreviation "min".

Sect. 3. And section thirty of chapter thirty-six of the 2 revised statutes of nineteen hundred and sixteen is further 3 amended by adding to said section thirty the words 'apples 4 packed, sold or offered for sale, distribution or transporta-5 tion in open packages shall be deemed to be adulterated if 6 their measure, quality, grade or purity do not conform in 7 each particular to the claims made by the seller to the pur-8 chaser or to the purchaser's servant or agent,' so that said 9 section, as amended, shall read as follows:

'Sect. 4. For the purpose of sections twenty-five to thirty-2 four both inclusive of this chapter, apples packed in a 3 closed package shall be deemed to be adulterated if their 4 measure, quality, grade or purity do not conform in each 5 particular to the claims made upon the affixed guaranty. 6 Apples packed, sold, or offered for sale, distribution or 7 transportation in open packages shall be deemed to be adul8 terated if their measure, quality, grade or purity do not con-9 form in each particular to the claims made by the seller 10 to the purchaser or to the purchaser's servant or agent.'
