STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE

AN ACT to Amend Sections Forty-five and Forty-six of Chapter One Hundred Forty-two of the Revised Statutes, Relating to Corrections and Charities.

Be it enacted by the People of the State of Maine, as follows:

Section 1. That section forty-five of chapter one hundred

- 2 and forty-two of the revised statutes be amended by insert-
- 3 ing after the word "thereto" in the third line of said section
- 4 the words 'and the state reformatory for men,' so that said
- 5 section as amended shall read as follows:

'Application of sections 41-44. The four preceding sec-

- 2 tions apply to convicts and officers in the county jails hav-
- 3 ing workshops attached thereto, and the state reformatory

- 4 for men, and in any county farm that may be established 5 for the reformation of inebriates.'
- Sect. 2. That section forty-six of chapter one hundred 2 and forty-two of the revised statutes is hereby amended 3 by inserting after the word "prison" in the second line of 4 said section the words 'or state reformatory for men' and 5 by inserting after the word "warden" in the second line of 6 said section the words 'or superintendent,' so that said section as amended shall read as follows:

'Measures to retake convicts, escaping; aiding convicts to 2 escape, how to be punished. When a convict escapes from 3 the state prison or state reformatory for men the warden 4 or superintendent shall take all proper measures for his 5 apprehension; and may in behalf of the state offer a reward 6 not exceeding fifty dollars for his apprehension and deliv-7 ery. Whoever, not standing in the relation of husband or 8 wife, parent or child, to the principal offender, conceals, o harbors or in any way aids any convict escaping from the 10 state prison, knowing him to be such; or furnishes such II convict with food, clothing, weapon, matches or other 12 article, or information that would aid him to escape recap-13 ture, shall be punished by imprisonment in the state prison 14 for a term not exceeding the whole time for which the con-15 vict was sentenced, or by fine not exceeding five hundred 16 dollars.'
