STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FORTY-THREE

AN ACT to Make Valid the Acts and Doings of Norway Pine Grove Cemetery Corporation and to Define Its Membership and Restrict Use of Its Funds.

Be it enacted by the People of the State of Maine, as follows :

Sec. 1. Ratification. All corporate acts, doings and proceedings of Norway Pine Grove Cemetery Corporation, all gifts, grants, bequests, donations and conveyances made to it, and all grants and conveyances made by it, are hereby ratified, confirmed and made valid.

Maud Kaemmerling, Clara L. Luck, Fred A. Lewis, Leon M. Longley, Forest M. Longley, Zeb L. Merchant, W. Mayford Mann, Herbert Melvin, Arthur H. Morgan, Arthur A. Noyes, Percy H. Nevers, Fred H. Perry, Victor M. Partridge, Luther F. Pike, Lester E. Richardson, H. Arthur Robbins, Owen D. Rich, Napoleon Roy, Richard A. Saleeby, Fred E. Smith, Albert A. Towne, Alton J. Thurston, Percy W. Twitchell, Carrie Tucker and Philip D. Wight, to-

gether with any and all other proprietors or owners of lots in said cemetery whether by deed, devise or inheritance are hereby declared to be shareholders or members of said corporation and entitled to the privileges of membership therein, and to 1 vote at its meetings; if there be more than 1 devisee or heir of any certain lot, the directors of the corporation at the time when the question arises, shall designate which of the devisees or heirs at law shall represent said lot, which designation shall continue in force until, by death, removed or other cause, another designation may become necessary.

Sec. 3. Application of property and money. All property held by this corporation at any time, and all monies resulting from the sale of lots, or of which said corporation may be otherwise possessed, shall be exclusively devoted and applied to the preservation, improvement, embellishment and enlargement of the said cemetery and the incidental expenses thereof, forever, and for no other purpose whatever, and no distribution, division or dividend thereof, or of any part thereof shall ever be made among the members, shareholders or stockholders.
