Committee Amendment "A" to S. P. 483, L.D. 1345, Bill "An Act to Incorporate the Town of Mars Hill School District."

Amend said Bill by striking out all of the emergency preamble.

Further amend said Bill by striking out in the 7th line of section 5 the figures " $2\frac{1}{2}$ " and inserting in place thereof the figure '4'.

Further amend said Bill by striking out in the 10th line of the 3rd paragraph of section 5 the figure "40" and inserting in place thereof the figure '25'.

Further amend said Bill by striking out all of section 9 and inserting in place thereof the following:

'Sec. 9. Effective date; referendum. This act shall take effect 90 days after the adjournment of the legislature only for the purpose of permitting its submission to the legal voters of the territory embraced within the limits of said district, present and voting at a special meeting called and held for the purpose or at an annual town meeting of the town of Mars Hill. Such special meeting or annual town meeting shall be held not later than 1 year after the effective In the event a special meeting is called for the date of this act. purpose, it shall be called, advertised and conducted according to the law relating to municipal elections; provided, however, that the board of registration in said town of Mars Hill shall not be required to prepare for posting, or the town clerk to post, a new list of voters, and for the purpose of registration of voters, said board shall be in session the three 3 secular days next preceding such special meeting, the 1st and 2nd days thereof to be devoted to registration of voters, and the last day to enable the board to verify the correctness of said lists and to complete and close up their records of said sessions. The town clerk shall prepare the required ballots on which he shall reduce the subject matter of this act to the following question: "Shall the Act to Incorporate the Town of Mars Hill School District be accepted?" and the voters shall indicate by a cross placed against the words "Yes"

or "No" their opinion of the same. This act shall take effect for all the purposes hereof immediately upon its acceptance by a majority vote of the legal voters voting at said meeting. The result of the vote shall be declared by the municipal officers of the town of Mars Hill and due certificate filed by the town clerk with the secretary of state.

Further amend said Bill by striking out the emergency clause at the end thereof.
