STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-FIVE

AN ACT Relating to Sales Tax on Containers and Packaging Materials.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 17, § 1, amended. The last sentence of the 10th paragraph of section 1 of chapter 17 of the revised statutes is hereby amended to read as follows:

"Retail sale" or "sale at retail" do not include the sale of containers, boxes, crates, bags, cores, twines, tapes, bindings, wrappings, labels and other packing, packaging and shipping materials when sold to persons other than manufacturers for use in packing, packaging or shipping tangible personal property sold by them or upon which they have performed the service of cleaning, pressing, dyeing, washing, repairing or reconditioning in their regular course of business and which are transferred to the possession of the purchaser of such tangible personal property."
