STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-SEVEN

AN ACT Increasing Salaries of Certain Officers of Penobscot County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to the salary of county commissioners of Penobscot county is hereby amended to read as follows:

'Penobscot, \$2,000 **\$2,200**,'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the deputy clerk of courts of Penobscot county, as amended by section 1 of chapter 394 of the public laws of 1955, is hereby further amended to read as follows:

'Penobscot, \$3,900; deputy clerk of courts, \$3,100 \$3,600,'

Sec. 3. R. S., c. 89, § 130, amended. That part of section 130 of chapter 89 of the Revised Statutes which relates to the salary of the county treasurer of Penobscot county, as amended by section 2 of chapter 394 of the public laws of 1955, is hereby further amended to read as follows:

'Penobscot, \$2,800 \$3,000,'

Sec. 4. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 of the Revised Statutes which relates to the salary of register of deeds of Penobscot county, as amended by section 4 of chapter 394 of the public laws of 1955, is hereby further amended to read as follows:

^{&#}x27;Penobscot, \$3,500, to be effective January +, 1955 \$3,750,'

Sec. 5. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes which relates to the salary of judge of probate of Penobscot county, as amended by section 6 of chapter 394 of the public laws of 1955, is hereby further amended to read as follows:

'Penobscot, \$3,650 \$5,000,'

Sec. 6. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of register of probate of Penobscot county, as amended by section 7 of chapter 394 of the public laws of 1955, is hereby further amended to read as follows:

'Penobscot, \$3,650 \$3,750,'
