STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
FIFTY-NINE

AN ACT Increasing Salaries of County Officers of Sagadahoc County.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 89, § 6, amended. That part of section 6 of chapter 89 of the Revised Statutes which relates to the salary of the county commissioners of Sagadahoc County, as amended by section 1 of chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc, ~~\$900~~ \$1,200.'

Sec. 2. R. S., c. 89, § 98, amended. That part of section 98 of chapter 89 of the Revised Statutes which relates to the salary of the clerk of courts of Sagadahoc County, as amended by section 63 of chapter 416 of the public laws of 1957, is further amended to read as follows:

'Sagadahoc, ~~\$3,240~~ \$3,600.'

Sec. 3. R. S., c. 89, § 130, amended. That part of section 130 of chapter 89 of the Revised Statutes which relates to the salary of the county treasurer of Sagadahoc County, as amended by chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc, ~~\$7,500~~ \$1,800.'

Sec. 4. R. S., c. 89, § 149, amended. That part of section 149 of chapter 89 of the Revised Statutes which relates to the salary of the sheriff of Sagadahoc

County, as amended by section 3 of chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc, ~~\$3,800~~ \$4,400.'

Sec. 5. R. S., c. 89, § 215, amended. That part of section 215 of chapter 89 of the Revised Statutes which relates to the salary of the register of deeds of Sagadahoc County, as amended by section 4 of chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc, ~~\$3,000~~ \$3,600.'

Sec. 6. R. S., c. 89, § 254, amended. That part of section 254 of chapter 89 of the Revised Statutes which relates to clerk hire in Sagadahoc County, as amended by section 5 of chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc County: for clerks in the office of register of deeds, ~~\$2,964~~ \$3,666; for clerks in the office of register of probate, ~~\$1,976~~ \$2,444; for clerks in the office of clerk of courts, ~~\$1,576~~ \$2,444.'

Sec. 7. R. S., c. 153, § 3, amended. That part of section 3 of chapter 153 of the Revised Statutes which relates to the salary of the judge of probate of Sagadahoc County, as amended by section 6 of chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc, ~~\$2,500~~ \$2,800.'

Sec. 8. R. S., c. 153, § 22, amended. That part of section 22 of chapter 153 of the Revised Statutes which relates to the salary of the register of probate of Sagadahoc County, as amended by section 7 of chapter 319 of the public laws of 1955, is further amended to read as follows:

'Sagadahoc, ~~\$2,000~~ \$2,500.'

Sec. 9. Effective date. The provisions of this act shall be retroactive to January 1, 1959.
