SECT. 3. *Be it further enacted*, That from and after the passage of this Act, the said patent line, the dividing line between the said towns of Scarborough and Saco, shall be and hereby is established and declared to be, a part of the westerly line of the County of Cumberland. County line established.

SECT. 4. *Be it further enacted*, That this Act shall take effect from and after its approval by the Governor. When to take effect.

Chapter 137.

AN ACT to incorporate the New Sharon Woolen Manufacturing Company.

SECTION 1. *Be it enacted by the Senate and House of Representatives in Legislature assembled*, That Stephen Howes, Ephraim Mayhew, Josiah Howes, Leonard W. Russell, Jacob Hayes, Charles G. Smith, Joseph Bullen, Thomas Buswell, James Snell, Benjamin Watson, John C. Butterfield, John Trask, Jr. and Oliver L. Currier and their associates and successors, be and they hereby are constituted and made a body politic and corporate, by the name of the New Sharon Woolen Manufacturing Company, with all the powers and privileges, and subject to all the duties and liabilities, provided in the several laws of this State, regulating manufacturing corporations, and are authorized to purchase and hold real and personal estate, not exceeding in value, at any one time, the sum of fifty thousand dollars; and the same may improve, lease, sell and convey, as other proprietors of real and personal estate may lawfully do. And said company are authorized to carry on, at New Sharon Falls, in the town of New Sharon, in the County of Franklin, the manufacture of wool, and such other materials as may be necessarily or conveniently connected therewith, and may erect and construct, such machinery, mills and other buildings, as may be useful for that purpose. SECT. 2. *Be it further enacted,* That after the full capital of fifty thousand dollars, shall have been assessed and paid, the stockholders in said corporation shall not be liable, individually, for the debts of said corporation: *Provided,* the treasurer of the same shall, annually, publish in one or more newspapers, printed in said County of Franklin, if any such there be, and if there be no public paper printed in said County, in one or more newspapers printed in an adjoining County, a correct statement of the amount of capital so paid in, and also a correct statement of the debts due from said company: *Provided,* that the debts of the corporation shall not, at any one time, exceed fifty per cent. of the capital stock of the corporation.

AN ACT to incorporate the Dexter Company.

SECTION 1. *Be it enacted by the Senate and House of Representatives in Legislature assembled,* That Samuel Farrar, Isaac Farrar and Lysander Cutler, and their associates and successors, be and they hereby are made and constituted a body politic and corporate, by the name of the Dexter Company, with all the privileges, and subject to all the duties and liabilities, provided in the several laws of this State, regulating manufacturing corporations; and are authorized to purchase and hold real and personal estate, not exceeding in value, at any one time, two hundred thousand dollars; and the same may improve, lease, sell and convey, as other proprietors of real and personal estate may lawfully do. And said company are authorized, to carry on, at Dexter, the manufacture of wool, and such other materials as may be necessarily or conveniently connected therewith: and may purchase, erect and construct, such machinery, mills and other buildings, as may be useful for that purpose.
