Chapter 170.

RESOLVE in favor of the Aroostook road.

Resolved, That the Land Agent of this State is hereby directed to carry into operation the law, approved March twenty-eighth, eighteen hundred and thirty-one, in relation to the opening and making a road from the military road to some point on the river St. John, near the mouth of Fish River, *Provided,* the Commonwealth of Massachusetts shall authorize and empower her Land Agent, to unite with the Land Agent of this State, in continuing the same, and in contributing her equal proportion with this State in making the same; and that the Land Agent of this State is hereby authorized to expend for this purpose the sum of seven thousand dollars, from money paid into the Land office.

Land Agent to carry into operation law of March 28, 1831.

Proviso.

Mass. shall pay an equal sum.

—\$7000 to be expended by Land Agent of Maine.

Chapter 171.

RESOLVE in favor of certain persons herein named.

Resolved, That there be paid, out of the treasury of this State, to Paul Doten Jun. and Stephen Kenniston, the sum of two dollars each; to Benjamin Garcelon and Amory Allen, five dollars each; to David Plummer, seven dollars and forty cents; to Farnham Jewett, five dollars and forty cents; to Henry Pennell, ten dollars; to Joseph E. F. Cushman, twelve dollars and sixty cents; to Samuel R. Clements, eighteen dollars and seventy-six cents; to Zenas P. Lane, twenty dollars and twenty cents; to Howard Baker, twenty-two dollars and forty cents; to Orville Knight, twenty-one dollars and eighty cents; to Cyrus K. Bodfish and Josiah Berry, twenty-four dollars each; in full for their services in the Aroostook expedition, in the year of our Lord one thousand eight hundred and thirty-nine.
