**Chapter 37.**

AN ACT relating to sheriffs, deputy sheriffs, constables and coroners.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

That from and after the passage of this act no sheriff, deputy sheriff, constable or coroner, shall be entitled to receive any fees as compensation for travel, to return any writ or other process commenced in any court in any action, when such action shall be settled seven days before the first day of any term of such court, to which such writ or process is returnable. *Provided* that no sheriff, deputy sheriff, constable or coroner, shall be deprived from receiving the present rate of travel for such distance as he may necessarily travel, to make service of any such writ or other process.

Deprived of fees in certain cases.

Proviso.

**Chapter 38.**

AN ADDITIONAL ACT modifying the government of the insane hospital and for other purposes.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

That the act passed during the present session of the legislature, entitled "an act modifying the government of the insane hospital and for other purposes," shall take effect and have force from and after the passage of this act, any law to the contrary notwithstanding.

Previous act enforced.

**Chapter 39.**

AN ACT providing for defining the limits of companies of infantry.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

That the mayor and aldermen of each city, the selectmen of each town, and the assessors of each plantation, shall ascertain, define and establish the limits of every company of infantry in their respective cities, towns and plantations, where the same has not been defined, or correctly defined, in pursuance of an act providing for the defining and establishing the limits of companies, approved March fifth, A. D. eighteen hundred and thirty six.

City and town officers, &c. to define the lines of infantry companies.
