CHAP. 139.**Chapter 139.**

Resolve in favor of Daniel Gilbert.

Land agent authorized to convey to Daniel Gilbert lot No. 24, &c.

*Resolved*, That in consideration of the sum heretofore paid for the use of the state, by the said Daniel Gilbert, the land agent be, and he hereby is, authorized and required to convey to him (the said Daniel Gilbert,) lot No. twenty four in the great isle of Haut.

**Chapter 140.**

Resolves for disinterring the remains of Hon. Joshua Cushman and Charles Waterhouse, and depositing the same in the state tomb.

For the removal of the remains of Hon. J. Cushman and Charles Waterhouse to the state tomb.

*Resolved*, That the superintendent of public buildings be instructed to remove the remains of the late Hon. Joshua Cushman, formerly a member of the House of Representatives, from Kennebec county, also the remains of the late Charles Waterhouse, former clerk of the house, who died at this metropolis in the discharge of their official duties, and deposit the same in the tomb erected for the interment of such members of the civil government of this state, as shall decease at Augusta, as soon as he shall deem it expedient so to do.

Inscriptions.

*Resolved*, That said superintendent cause to be suitably inscribed upon the monument, surmounting the tomb, the names above specified, with such other inscriptions as shall correspond with those already engraved thereon.

*Resolved*, That said superintendent be authorized and directed, if necessary, to supply a new and suitable coffin for the remains of the late Hon. William Delesdernier.

*Resolved*, That the governor and council be requested to defray from their contingent fund, any expenses arising from the execution of the foregoing resolves.

**Chapter 141.**

Resolve authorizing the land agent to locate and open a road from the Aroostook to the Saint John river.

*Resolved*, That the land agent of Maine, in concurrence with the land agent of Massachusetts, be, and he hereby is, directed to extend the location and opening of the state road, from the Aroos-
