**Chapter 156.**

Resolve authorizing the land agent to remove and dispose of the state's boom on the Aroostook river.

*Resolved*, That the land agent be, and he hereby is authorized to take the state's boom in letter D, in the first range of townships west from the east line of the state, out of the Aroostook river, and remove such piers as, in his opinion, obstruct the navigation of said river; and sell such parts of said boom as he may find a market for.

Land agent to remove and dispose of state boom in Aroostook river.

**Chapter 157.**

Resolves in relation to state valuation of the towns of Bethel and Hanover.

*Resolved*, That the number of polls set to the valuation of the town of Bethel, in the county of Oxford, be three hundred and thirty one, and the amount of estates set against said town, be two hundred and sixteen thousand, one hundred and thirty eight dollars, instead of the number and sum fixed by the valuation of eighteen hundred and forty one; and that the valuation of the town of Hanover, which comprises what was formerly Howard's gore, with a part of the town of Bethel, in said county, be forty eight polls, and thirty thousand, eight hundred and seventy eight dollars, as estates, and all state and county taxes shall be assessed accordingly.

Valuation of Bethel and Hanover equalized.

**Chapter 158.**

Resolve authorizing the sale of a meeting house in the town of Sedwick.

*Resolved*, That the town of Sedgwick may, by a majority of votes at a legal meeting of the inhabitants thereof, authorize the selectmen, or such agents of said town, as they may appoint for the purpose, to sell at public auction or private sale, the meeting house—the building of which was authorized by the inhabitants of said town, at a legal meeting holden May 27, 1793; and the avails of such sale shall be disposed of under the direction of said selectmen or agents, in conformity, as near as may be, with the provisions of the third section of the nineteenth chapter of the revised statutes.

Inhabitants of Sedgwick authorized by their agent to sell their meeting house.

Proceeds, how disposed of.

*Provided*, that a majority of the proprietors of said house do not formally object to said sale, at the meeting called to authorize the same.

Proviso.
