**Chapter 162.**CHAP. 162.

Resolve in relation to the distribution of the annual school fund.

*Resolved*, That the treasurer of the state be, and he hereby is, authorized and directed, in apportioning the annual school fund among the several cities, towns and plantations in this state, to assume as the basis of apportionment among such cities, towns and plantations, (except Madawaska) as had not returned their number of scholars to the office of the secretary of state, up to the tenth day March, instant, the number of persons between the ages of four and twenty one years, in those cities, towns and plantations, as stated in the apportionment of the bank tax of last year; and among those in the Madawaska settlements, as returned by the census of 1840.

Distribution of the annual school fund.

Basis, where no returns have been made.

**Chapter 163.**

Resolve transferring the state valuation of that part of the town of Hope set off to the town of Appleton.

*Resolved*, That the number of polls, one hundred and thirty six, and the real and personal estate, amounting to ninety thousand seven hundred and thirteen dollars, be deducted from the town of Hope and be added to the town of Appleton, making the state valuation of Appleton two hundred and ninety four polls, and real and personal estates one hundred and eighty two thousand, nine hundred and seventy dollars; and the state valuation of Hope will stand one hundred and ninety three polls, and real and personal estate, one hundred thirty nine thousand, one hundred and three dollars.

Valuation of a part of the town of Hope transferred to the town of Appleton.

**Chapter 164.**

Resolve in favor of Jedediah Fairfield, of Hampden.

Jedediah Fairfield, of Hampden, county of Penobscot, contemplating and intending to avail himself of the provisions of the third chapter of the revised statutes, regulating the sale and settlement of the public lands, having erected and put in operation a good and substantial saw mill in township number four, in the fifth range from the east line of the state, therefore

Preamble and resolve in favor of Jedediah Fairfield.
