**Chapter 167.****CHAP. 167.**

Resolve in favor of Abner B. Thompson and others.

*Resolved*, That Abner B. Thompson and the heirs or assignees of Roscoe G. Greene, be allowed three years, from the approval of this resolve, to perform the settling duties on certain lots of land in township number one, indian purchase, as required by the conditional deed of said land, from the state, to the said Thompson and Greene; *provided*, they shall pay to the state, on or before the first day of May next, the balance due for said land.

**Chapter 168.**

Resolve for the purchase and distribution of the Maine Register.

*Resolved*, That the secretary of state be directed to procure a suitable number of copies of the Maine Register for the present year, and distribute one copy to each town and organized plantation in this state: *Provided* the price shall not exceed forty two cents for each copy.

Purchase and distribution of the Maine register.

Proviso.

*Resolved*, That the secretary of state shall cause to be prepared an appendix, containing the statement in relation to the incorporation of towns and boundaries of counties, made in pursuance of an order of the house of representatives, passed February fourth; a list of all executive appointments, and such alterations as may be made in the state valuation up to the time of the passage of these resolves, and such other additions and corrections as he may deem necessary and expedient; also that he procure a sufficient number of Anson's map of Maine, new and revised edition, containing the boundary lines under the treaty of 1842, to be bound up with the volume; and that his account for the additional expense of said appendix and map be audited by the governor and council, and the governor is hereby authorized to draw his warrant on the treasury for the amount that may be allowed.

Secretary to cause an appendix to be prepared.

**Chapter 169.**

Resolves in favor of John H. Pillsbury and Ebenezer Webster.

*Resolved*, That there be paid to John H. Pillsbury and Ebenezer Webster, out of the treasury, the sum of two thousand, five hun-

dred dollars, on account of damage suffered by them from detention of their timber, in the Aroostook boom, in the spring of 1839.

Said sum to be added to the account against the U. States.

*Resolved*, That the governor be requested to cause the amount paid Messrs. Pillsbury and Webster, under the foregoing resolve, to be added to the claim of Maine upon the United States government, under the provisions of the late treaty of Washington.

**Chapter 170.**

Resolve directing the collection of William Emerson's note.

For the collection of Wm. Emerson's note.

*Resolved*, That the treasurer of state be directed to collect the amount of principal and interest, due the state, from William Emerson, as per note dated February 25, 1835, which note became due A. D. 1838, by suit or by foreclosing the mortgage, given to secure the payment of said note, as he may deem for the interest of the state.

**Chapter 171.**

Resolve in favor of Rendol Whidden.

In favor of Rendol Whidden.

Time of payment on three notes of hand extended.

Proviso.

Proviso.

*Resolved*, That the time of payment of one half of the balance due the state on three several notes of hand against Rendol Whidden, be extended one year from the twentieth day of April next; and the time of payment of the other half of said balance be extended two years from the said twentieth day of April next: *provided* the said Whidden or his assigns quitclaims by deed all his right, title and interest in and to lot number 43, to John Collier, whenever the said Collier quitclaims by deed all his right, title and interest in and to lot number 42, to said Whidden or his assigns. *Provided, however*, that this extension shall not affect the lien the state has upon any land or timber, as security for the payment of said notes, or the equitable interests of the Washington county bank in said land or timber.
