Chapter 232.

CHAP. 232.

An act to incorporate the Lincoln Flax and Hemp Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

That Horace P. Hubbard, Dimon Hubbard, Abel Merrill, Joseph Merrill, Uriah Jack and Obed Merrill, together with their associates and successors, are hereby constituted and made a body corporate and politic, by the name of the Lincoln Flax and Hemp Company, with all the powers and privileges, and subject to all the duties and liabilities provided in the laws of this state concerning manufacturing corporations ; and they are hereby authorized to hold and use a capital stock of twenty thousand dollars.

Chapter 233.

An act additional concerning the city of Portland.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. The city council of the city of Portland is hereby authorized and empowered to make, ordain and publish such rules and regulations in relation to the preservation of Portland harbor, including all of said harbor within the limits of said city, and extending to low water mark on the shore of Cape Elizabeth, as may seem necessary and expedient. And said city council is further authorized to provide for the regulation and management of all vessels within the limits aforesaid, and all other matters having relation thereto, and for the purposes aforesaid to pass such ordinances as may be necessary and expedient, and as shall not be inconsistent with the constitution and laws of the United States, and of this state ; and to affix such penalties for the breach of any of such regulations as may be deemed proper, to be recovered in an action of debt, in the name, and for the use of said city, in any court of competent jurisdiction.

City council, power and authority of.

Penalties, &c.

SECT. 2. For the better effecting the purposes of this act, said city council are further authorized to appoint such officer or officers as may be deemed necessary.
