## Chapter 365.

Resolve providing for the payment of interest to plantations in certain cases.

Payment of interest to plantations.

*Resolved*, That whenever the inhabitants of any township or tract which has been, or may hereafter be, organized for election purposes or otherwise, in which lands have been reserved for public uses, from which any funds may have arisen from the sales of the timber and grass thereon, and the same has actually been paid into the treasury of the state, the governor with the advice and consent of council is hereby authorized to draw his warrant in favor of the clerks of such plantations upon the treasurer of state, for the amount of interest which has accrued up to the first day of January annually, upon such fund, at the rate of six per cent. per annum—*provided*, that before such warrant is drawn, satisfactory evidence shall be produced to the governor and council, that one or more school districts have been organized in such plantation applying for the interest aforesaid, and *provided further* that the certificate of the treasurer of state shall fix the sum for which such warrant shall be drawn.

Proviso.

## Chapter 366.

Resolve in favor of certain members of the legislature who visited the state prison.

Payment of committee on state prison.

*Resolved*, That there be paid out of the treasury of the state the following sums, namely :

To James Lancaster, six dollars and fifty cents ;  
 John Bridges, six dollars and fifty cents ;  
 William F. Carlton, six dollars and fifty cents ;  
 William Hopkins, six dollars and fifty cents ;  
 Eliphas C. Bean, six dollars and fifty cents ;  
 Benjamin Tarbox, six dollars and fifty cents ;  
 Samuel Roberts, six dollars and fifty cents ;  
 John B. Wildes, six dollars and fifty cents ;  
 Alden Kennedy, six dollars and fifty cents ;

The same being for expenses incurred in visiting the state prison, by direction of the legislature.
