**Chapter 214.**CHAP. 214.

An act to set off a portion of the town of Waterborough and annex the same to the town of Shapleigh.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

From and after the passage of this act, all that part of the farms, with the buildings thereon, of William Pike and Timothy F. Pike, situate in the town of Waterborough, is hereby set off from said town of Waterborough and annexed to the town of Shapleigh.

Territory set off from Waterborough and annexed to Shapleigh.

[Approved March 14, 1854.]

**Chapter 215.**

An act to authorize the city of Bangor to collect taxes assessed upon the polls and estates of said city, for the year eighteen hundred and fifty-three.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

SECT. 1. The city of Bangor shall have authority to cause to be collected in due form of law, the taxes assessed upon the polls and estates in said city, upon the valuation taken for said city, for the first day of May, eighteen hundred and fifty-three, and committed to the treasurer and collector of said city by the assessors of said city, for collection, with their warrant, under date of August twenty-second, eighteen hundred and fifty-three, and to cause to be paid over to the treasurer of the town of Veazie such proportion of the sums so collected, as the committee provided for in the act incorporating the said town of Veazie may award to said town.

Certain taxes to be paid to the town of Veazie.

SECT. 2. This act shall take effect from and after its approval by the governor.

An act to incorporate the Frontier Steamboat Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*
