CHAP. 355.**Chapter 355.**

An act to prevent the destruction of pickerel in Cochnewaggan pond.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Pickerel; protection of.

SECT. 1. If any person shall take or destroy, otherwise than by hook and line, any pickerel in Cochnewaggan pond, in the town of Monmouth, Kennebec county, or in any of the streams emptying into or issuing out of said pond, he shall forfeit and pay, for every pickerel so taken and destroyed, a fine of one dollar, to be recovered by action of debt to the use of any person who may sue for the same.

Penalty for violation.

SECT. 2. An act to prevent the destruction of pickerel in Cochnewaggan pond, approved March fourth, eighteen hundred and fifty-two, is hereby repealed.

Act of 1852 repealed.

SECT. 3. This act shall take effect and be in force from and after its approval by the governor.

Chapter 356.

An act in relation to the dams on the Passadumkeag river.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Grand Falls dam, agent to determine value of.

SECT. 1. John Morrison of Orono, in the county of Penobscot, may determine the present value of the dams on the Grand falls, on the Passadumkeag river, and return the same to the land agent, to be filed in the land office; and the Grand Falls Dam Company may demand and receive the sum of eight cents per thousand feet, board measure, woods scale, for all logs and lumber which may pass the same, and shall have a lien on all logs and lumber which may pass over their said dams, with the same remedies to enforce the payment of the same as is provided in the act incorporating the Nickertou Dam Company; and when the sum and interest returned as aforesaid has been paid by proceeds of toll, the dams shall belong to the public, and the tolls shall cease, and no further toll shall be taken on the Nickertou dam. This act shall not take effect until it shall be accepted by the said Grand Falls Dam Company.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.
