**Chapter 136.**

CHAP. 136.

Resolve in favor of the counties of Androscoggin and Sagadahoc.

*Resolved,* That the secretary of state be, and he hereby is, directed to furnish the clerks of the courts, judges and registers of probate, treasurers, sheriffs, prison keepers, and registers of deeds for the counties of Androscoggin and Sagadahoc, copies of such laws, resolves and reports of this state as have heretofore been furnished like officers of other counties; and the books aforesaid shall be the property of said counties, and shall be delivered over by the officers aforesaid to their successors in office.

Secretary of state directed to furnish certain county officers with books.

**Chapter 137.**

Resolve in favor of certain members of the legislature who visited the state reform school.

*Resolved,* That there be paid out of the treasury of the state the sum of nine dollars to each of the following persons: J. L. Cutler, W. H. Vinton, Elisha Clark, Charles Paine, Moses Whittemore, J. T. Beath, George Libby, N. B. Hubbard, J. A. Thompson, C. G. Came, members of the legislature, appointed to visit the state reform school by an order passed at the present session; the said sum being in full for traveling expenses of said persons in the discharge of that duty.

Committee of visitation to reform school, compensation for services.

**Chapter 138.**

Resolve in aid of Hartly Hamilton.

*Resolved,* That the land agent be authorized and directed to cancel and give up to Hartly Hamilton a note of hand against said Hamilton, on which is due the sum of thirty-two dollars and twenty-five cents, the said Hamilton having satisfied the said note.
