**Chapter 160.****CHAP. 160.**

Resolve making appropriation for religious services at the insane hospital.

*Resolved,* That there be appropriated, and paid out of the state treasury, one hundred dollars, to be expended under the direction of the trustees of the insane hospital, in procuring religious services for the same.

**Chapter 161.**

Resolve to authorize plantation number fourteen county of Washington to reorganize for election purposes.

*Resolved,* That plantation number fourteen, in the county of Washington, may reorganize itself into a plantation for election purposes, and for that purpose the assessors of said plantation, for the year eighteen hundred and fifty-three, or a majority of them, may issue their warrant directed to some one of the inhabitants of said plantation, directing him to notify and warn a meeting of the electors of the same at some central place in said plantation, in the month of May, by posting up a notice thereof and the object of said meeting in two or more public places; said electors shall proceed as is provided in the act passed at the extra session of the legislature of eighteen hundred forty, entitled "An act in relation to elections," approved October second, eighteen hundred and forty. This resolve shall take effect on and after its passage.

**Chapter 162.**

Resolve in favor of the abolition of spirit rations in the United States navy.

*Resolved,* That our senators in congress be instructed, and our representatives requested, to use all reasonable efforts to effect the passage of an act of congress abolishing the spirit rations now allowed to seamen in the United States navy, and the substitution therefor of an equivalent in money.
