**Chapter 49.**

Resolve to protect the rights of Passamaquoddy Indians.

*Resolved,* That the agent of the Passamaquoddy Indians is hereby required to ascertain whether the rights which said Indians have in certain meadows, in Indian township, have been violated; and if he shall find that their rights have been infringed upon, he is required to take measures forthwith to put said Indians into full possession of all the rights, privileges and immunities, secured to them in the deed conveying to certain parties the right to cut the timber and grass on said township, executed in pursuance of a resolve approved March thirtieth, eighteen hundred and fifty-three.

**Chapter 50.**

Resolve for encouraging the building of mills, in Letter C, range one.

*Resolved,* That the land agent is hereby authorized and directed to deed to Isaac Wortman four lots of land, of one hundred and sixty acres each, to be selected by the said Wortman, in township Letter C, range one, from lands not otherwise disposed of, when the said Wortman shall satisfy the land agent that he has built a good and substantial mill for the manufacturing of flour, oat and other meals, and a saw-mill, for the manufacturing of boards and scantling, with circular saws for the manufacturing of laths; said mills to be located on said township.

**Chapter 51.**

Resolve providing for the building of a stone wall, at Pleasant Point.

*Resolved,* That for the purpose of building a stone wall from the county road in Perry to St. Andrews' bay, on the line between the land owned and occupied by George A. Hudson and the Indian land, so called, at Pleasant Point, there be, and hereby is appropriated a sum, not exceeding eighty dollars, to be expended under the direction of the agent of the Passamaquoddy tribe of Indians; *provided,* the said George A. Hudson shall appropriate a sum in labor or money sufficient to finish said wall, to the satisfaction of said Indian agent.
