Chapter 137.

CHAP. 137.

An act to incorporate the State of Maine Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. John A. Poor, Samuel S. Starbird, their associates, successors and assigns, are hereby incorporated and made a body politic by the name of the State of Maine Company, for the purpose of carrying on the business of printing and publishing, in the city of Portland in this state, with all the powers incident to corporations under the general laws of this state.

SECT. 2. The capital stock of said company shall consist of not more than three hundred, nor less than one hundred shares of one hundred dollars each.

Chapter 138.

An act to make valid the doings of the town officers of the town of Sebec.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. The doings of the selectmen of the town of Sebec acting as assessors for the year of our Lord one thousand eight hundred and fifty-six, in assessing and committing all sums of money raised by and apportioned to said town, as taxes for said year, are hereby declared to be valid and sufficient in law, notwithstanding any omission of said selectmen to take the assessors oath before assessing and committing said taxes to the collector for collection.

Sebec selectmen, doings of as assessors for 1856, made valid.

SECT. 2. The inhabitants of said town are hereby authorized at any meeting called for the purpose, to choose a collector of taxes to collect the unpaid taxes of said town for the year of our Lord one thousand eight hundred and fifty-five, and said collector shall give such bond as is by law required of collectors of taxes, and he is hereby fully authorized to collect said taxes according to his warrant.

SECT. 3. The assessors of the town of Sebec for the time being are hereby fully authorized to commit by warrant in due form of law, as in other cases of commitment of tax bills, said unpaid tax bills to the collector so chosen, for collection.

SECT. 4. This act shall take effect from and after its approval by the governor.
