## CHAP. 182.

## Chapter 182.

An act to change the name of the Methodist Society in Portland.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Methodist society in Portland.

—name of changed.

May hold real and personal estate.

Powers, privileges, &c.

SECT. 1. The society heretofore known by the corporate name of "The Methodist Society in Portland," shall be allowed to take the name of The Chesnut-street Methodist Society in Portland.

SECT. 2. The said society may purchase and hold personal and real estate to an amount not exceeding seventy-five thousand dollars; and may exercise all the powers and privileges, and shall be subject to all the duties and liabilities of similar corporations in this state.

## Chapter 183.

An act additional to an act to authorize the town of Milo to erect and maintain a toll bridge for a limited time, approved August eighth, eighteen hundred forty-eight.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Milo, town of, authorized to erect and maintain toll bridge.

—may fix terms of toll.

—not exceeding one year.

In addition to the powers granted to the county commissioners of Piscataquis county in section eighth of chapter one hundred fifty-five of the acts and resolves of the year eighteen hundred forty-eight, they may fix the terms upon which, for a limited time not exceeding one year, permits to pass over the bridge referred to in the act to which this is additional, may be granted to individuals, families and corporations, but not so as to diminish or impair the security of the loan therein referred to, or to delay the payment of the same.

## Chapter 184.

An act to incorporate the Fayette Mutual Fire Insurance Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Andrew Sturtivant, Samuel Tuck, Samuel Hubbard, J. W. C. Jones, Hosea Elliot, Stephen C. Tuck, Daniel Judkins,

Corporators.

James W. Hutchinson, F. A. Chase and all other persons who may hereafter become members of said company, are hereby incorporated and made a body politic and corporate, by the name of the Fayette Mutual Fire Insurance Company, with full power to insure any species of real or personal property against loss or damage by fire; *provided*, that no policy shall be issued by said company until application shall have been made for twenty thousand dollars.

Corporate name.  
Power of insurance.  
Proviso.

SECT. 2. The said corporators are hereby authorized and empowered to exercise all the rights and privileges conferred upon such corporations by the laws of this state, and subject to all the liabilities and the restrictions thereof.

Rights, privileges, &c.

### Chapter 185.

An act to authorize the extension of Jack's Point Wharf in Newcastle.

*Be it enacted by the Senate and House of Representatives in Legislature assembled*, as follows :

John Glidden, Samuel Averill, second, and others who are or may become owners of Jack's Point Wharf, so called, in Newcastle, are hereby authorized and empowered to build and extend said wharf in a southeasterly direction towards and into the channel of Damariscotta river to a line not exceeding twenty-five feet beyond the present limits of said wharf; *provided*, that nothing in this act shall be so construed as to authorize the extending of said wharf either up or down the river beyond the present width of said wharf as now constructed.

Authorized to build and extend wharf.

Proviso.

An act to incorporate the Woodland Cemetery Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled*, as follows :
