**Chapter 346.**

CHAP. 346.

Resolve designating and locating certain townships lying in the county of Franklin for settlement.

*Resolved*, That townships numbered three, range four, and three range five, west of Bingham's Kennebec purchase, in the county of Franklin, be, and the same are hereby designated and located for settlement, and the land agent is hereby authorized to locate a road in said townships leading from the Rangely settlement north-erly towards the Canada line, and cause the land to be lotted for settlement, and that there be appropriated and paid out of the state treasury the sum of five hundred dollars, to be expended under the direction of the land agent upon said road when located.

**Chapter 347.**

Resolve in favor of the inhabitants of the town of Chester.

*Resolved*, That the land agent is hereby authorized to pay to the town of Chester the interest on the four hundred dollars provided for in a resolve approved August twenty-eight, eighteen hundred and fifty, from the approval of said resolve to the time of paying over the same to the town of Chester; *provided*, that the land shall sell for a sum sufficient to pay said interest in addition to the said four hundred dollars provided for in said resolve.

**Chapter 348.**

Resolve in aid of building a bridge across the Aroostook river.

*Resolved*, That there be appropriated and paid out of the state treasury, to be expended under the direction of the land agent, the sum of three thousand dollars, to aid in building a bridge across the Aroostook river on the eastern Aroostook road in the town of Maysville; *provided*, that the inhabitants of the county of Aroostook shall raise and expend a sum equal in amount at least to the above appropriation, and sufficient to complete said bridge to the satisfaction of the land agent, and the whole amount so appropriated and so raised shall be expended under the direction of the land agent.
