**Chapter 326.**

CHAP. 326.

Resolve relating to an appropriation for common schools.

*Resolved*, That the land agent, under the instructions of the governor and council, be and he is hereby directed to sell the timber and lumber upon ten townships of land belonging to the state not already selected for the permanent school fund, and not otherwise appropriated, after advertising for six months in the state paper, in the paper nearest to where the land is situated, and in the Bangor Daily Whig and Courier, to receive at the land office sealed proposals for the timber and lumber on said ten townships of land in one-eighth sections, and the purchasers to have ten years to take off said timber and lumber, and no longer. A record of the proposals shall be made and kept in the land office, which shall be open to any one after the day of sale. The proceeds of said sale shall be by him paid into the state treasury, and placed to the credit of the common school fund.

**Chapter 327.**

Resolve to appropriate money for the completion of the bridge at Haynesville.

*Resolved*, That there be appropriated and paid out of the state treasury, to be expended by the land agent, the sum of five hundred dollars, to complete the bridge at Haynesville.

**Chapter 328.**

Resolve in favor of the minor children of Mrs. Mary Hale.

*Resolved*, That there be paid out of the treasury of the state out of any moneys not otherwise appropriated, to the two minor children of the late Mrs. Mary Hale of plantation number four, range one, in the county of Penobscot, deceased, the sum of twenty-five dollars, the same having been due her from said plantation at the time of her decease, by virtue of an act to provide support for families of volunteers, approved March twenty-fifth, eighteen hundred and sixty-three.
