CHAP. 121.

**Chapter 121.**

An act to prevent the destruction of fish in ponds and streams in the town of Orneville.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Penalty, how recoverable and to whom accruing.

SECT. 1. Any person who shall hereafter take any trout or other kinds of fish by the use of a net or nets, in any ponds or streams in the town of Orneville, in the county of Piscataquis, shall upon conviction thereof, before any court competent to try the same, pay a fine not exceeding twenty dollars, one half to the complainant and the other half to the town where the offence is committed.

Forfeiture of nets.

SECT. 2. If any person shall set a net in any pond or stream in said town for the purpose of taking fish in violation of the provisions of this act, upon conviction thereof as aforesaid, he shall forfeit to the complainant such net though no fish be taken thereby.

**Chapter 122.**

An act to authorize Thomas W. Gamage to build a bridge in the town of Bristol.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Bridge to be free.

SECT. 1. That Thomas W. Gamage be authorized and empowered to erect and maintain a free bridge across the waters of St. Johns bay, in the town of Bristol, at or near Rutherford's island to Rutherford's island ; *provided* said bridge shall be substantially made of good materials, well railed, and convenient for travelers thereon, free of toll.

How constructed.

SECT. 2. This act shall take effect when approved by the governor.

Approved February 20, 1866.

**Chapter 123.**

An act to authorize Eliphalet Thorp and Frank Thorp to extend their wharf in the town of Boothbay.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Distance and direction of extension.

Eliphalet Thorp and Frank Thorp are hereby authorized to extend their wharf in Boothbay one hundred feet towards the channel.
