#### Chapter 50.

Снар. 50.

An act in addition to and amendatory of section three, chapter one hundred and three of the public laws of eighteen hundred sixty-two, relating to change of school books.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Any person or persons violating the provisions of section three, chapter one hundred and three of the public laws of eighteen hundred and sixty-two, shall be punished by fine not exceeding five hundred dollars, to be recovered in an action of debt, on the complaint of any school official or person aggrieved.

Penalty for violation of provisions of pub. laws 1862, chap, 103, sect. 3 relating to change of school books.

Approved March 9, 1869.

#### Chapter 51.

An act to amend section second, chapter one hundred and thirty, of the acts of eighteen hundred sixty-two, relating to the purchase of intoxicating liquors by towns.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section second, chapter one hundred thirty of the acts of eigh- Public laws 1862 teen hundred sixty two, is hereby amended, by striking out of chap. 130, sect. 2, amended. said section all after the words "person or persons," in the ninth line, so that it shall read as follows:

Immediately after appointing such commissioner, the Notice of appointgovernor shall issue to the municipal officers of the several cities, towns and plantations of this state, a notice of the name and place of business of said commissioner; and it shall be the duty of such municipal officers to purchase such intoxicating liquors as they may keep on sale for the purpose specified in this act, of such commissioner, or of such other municipal officers as have purchased such intoxicating liquors of said commissioner, and of no other person or persons; provided that the commissioner appointed Residence and under the provisions of this act, shall be a citizen of Maine, and of commissioner. shall keep his place of business in this state.'

#### Chapter 52.

An act to amend chapter forty-nine of the revised statutes, in relation to insurance companies.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:
