CHAP. 53.**Chapter 53.**

An act to incorporate the Houlton Woolen Manufacturing Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Corporators.

SECT. 1. E. C. Blake, A. H. Fogg, J. H. Bradford, Llewellyn Powers, Jefferson Cary, H. T. Frisbie, Charles P. Tenney, Eben Woodbury, T. P. Packard, E. D. French and their associates, successors and assigns, are hereby incorporated into a company, with all the powers, privileges and immunities, and subject to all the duties and liabilities, provided in the laws of this state concerning manufacturing corporations, and are authorized to purchase, hold, improve, lease or sell, real and personal estate, not to exceed at any one time in value the sum of one hundred thousand dollars, and divide the same into shares as they may deem convenient.

Powers, privileges and liabilities.

Location.

SECT. 2. Said company is authorized to carry on at Houlton, in the county of Aroostook, the manufacture of woolen goods and any other articles necessarily or conveniently connected therewith.

Articles of manufacture.

First meeting, how called.

SECT. 3. Any three of the corporators named in this act may call the first meeting of the corporation, by giving notice thereof in any newspaper published in Houlton, ten days at least before said meeting.

SECT. 4. This act shall take effect when approved.

**Chapter 54.**

An act to authorize the construction of a wharf in the town of Vinalhaven.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Construction of wharf authorized.

SECT. 1. Kittridge Webster and Company, their heirs and assigns, are hereby authorized to construct and maintain a wharf in front of their quarry and land, on the easterly side of Carver's harbor, in the town of Vinalhaven; commencing at their land and extending into the tide waters of said Carver's harbor one hundred and fifty feet.

May extend into tide water 150 feet.

SECT. 2. This act shall take effect when approved.
