CHAP. 67.

Chapter 67.

An act to amend chapter three hundred eighty-two of the laws of eighteen hundred sixty-seven, entitled, "an act to incorporate the Winterport Railroad Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Amended.
Number of shares limited.

SECT. 1. Section two of chapter three hundred eighty-two of the laws of eighteen hundred sixty-seven, entitled "an act to incorporate the Winterport Railroad Company," is hereby amended by striking out the word "three," and inserting the word 'five,' so that the section as amended shall read as follows: 'The capital stock of said corporation shall consist of not less than one thousand nor more than five thousand shares.'

SECT. 2. This act shall take effect when approved.

Chapter 68.

An act to annex Eaton, Sheridan and Forestville plantations to the town of Lyndon.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Certain plantations annexed to Lyndon.

SECT. 1. Eaton plantation, composed of the Eaton grant, so called, and Sheridan plantation, composed of that portion of the township of H which lies east of the Aroostook river, and Forestville plantation, composed of the township of I, all in range two west from the east line of the state, in the county of Aroostook, are hereby annexed to the town of Lyndon.

All taxes assessed to be collected and paid to said town.

SECT. 2. All uncollected taxes legally assessed in said plantations shall be collected by the collector of each of said plantations and paid over to the treasurer of said town; and the highway surveyors thereof shall account with the selectmen of said town the same as they are now required to do with the assessors of said plantations; and said town shall assume and pay all debts and liabilities of every description of said plantations and may be sued therefor if not paid by them; and all rights of said plantations in lands sold or forfeited for taxes therein and not redeemed, are hereby transferred to said town, and vested in it as fully as the same are now held by said plantations.

Said town shall assume all debts, &c., of said plantations.

SECT. 3. The school districts in said plantations shall remain as now organized until altered by said town.

SECT. 4. This act shall take effect when approved.
