Chapter 83.

CHAP. 83.

An act to incorporate the Channing Circle.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. That Pamela A. S. Dearborn, Susan H. Boyd, Mary W. H. Morrison, Mary S. Emery, Almira P. Lewis, Susan H. Smith, Anne L. Pierce, Helen A. Gilman, Mary C. Fox and Octavia Fox, of Portland, their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Channing Circle, for the purpose of doing good and for benevolent and charitable purposes, with power under such corporate name to sue and be sued, make contracts, have a common seal, purchase, own, convey and manage real and personal estate, and the same to control and dispose of; to make by-laws not repugnant to the laws of the state, and to have and enjoy all the rights, powers and privileges necessary to carry into effect the object of said corporation.

Corporators.

Corporate name.

Purpose.

May own real and personal estate.

SECT. 2. Said corporation is hereby authorized for the purposes mentioned in section one to take by purchase, bequest, or otherwise, property to the amount of five thousand dollars.

May hold property to amount of \$5,000.

SECT. 3. Any one of the persons named in the first section may call the first meeting of the corporation by giving notice thereof to each of her associates.

First meeting

SECT. 4. This act shall take effect when approved.

Chapter 84.

An act respecting investments of the sinking funds of the Atlantic and St. Lawrence Railroad Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. The commissioners of the sinking funds of the Atlantic and St. Lawrence Railroad Company, established under the several acts passed in the years eighteen hundred and forty-eight and eighteen hundred and fifty, for the redemption of the loans of credit made by the city of Portland to said company, are hereby authorized to invest the moneys of said funds in any of the permanent debt of the city.

Commissioners of sinking funds of A. and St. L. Railroad Co. may invest the moneys of said funds in debt of city.

SECT. 2. This act shall take effect when approved.
