**Chapter 93.****CHAP. 93.**

An act authorizing Henry Rollins and others to build wharves in Brewer.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Henry Rollins and E. H. Rollins are hereby authorized to extend their wharves in the town of Brewer, viz : From a point near the north line of the Wilson shipyard, in the town of Brewer, into the tide waters of the Penobscot river two hundred feet, and from the south line of the Cooper shipyard two hundred and fifty feet; also permission to extend the wharves between the ferry way and Oaks and Doan's shipyard fifty feet from the end of Long wharf.

Extension of wharf into tide waters authorized.

SECT. 2. This act shall take effect when approved.

Approved February 17, 1869.

**Chapter 94.**

An act to prevent the taking of pickerel in Pleasant pond and in the outlet and inlet to the same in the town of Turner.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The taking of pickerel in the waters of Pleasant pond, and in the inlet and outlet to said pond, in the town of Turner, is hereby prohibited and made unlawful for and during the term of five years from the passage of this act.

Taking of pickerel in certain waters prohibited for term of five years.

SECT. 2. Any person who shall take from the waters described in the first section of this act any pickerel, within the time named in the foregoing section of this act, shall forfeit the sum of five dollars, to be recovered by complaint before a trial justice, or by an action of debt, one-half to the prosecutor and the other half to the town of Turner.

Penalty.

**Chapter 95.**

An act to make valid the doings of the town of Houlton in aid of the Houlton Branch Railroad.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The doings of the town of Houlton in town meeting, held in said town on the twenty-third day of November, in the
